

**FIRST ENGROSSMENT
with House Amendments
ENGROSSED SENATE BILL NO. 2238**

1 A BILL for an Act to reimburse school districts and nonpublic schools for expenses incurred in
2 providing cardiopulmonary resuscitation training to students; and to provide an appropriation.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** There is appropriated out of any moneys in the general
5 fund in the state treasury, not otherwise appropriated, the sum of \$450,000, or so much of the
6 sum as may be necessary, to the superintendent of public instruction for the purpose of
7 reimbursing school districts and nonpublic schools for costs incurred in providing
8 cardiopulmonary resuscitation training to students, for the biennium beginning July 1, 2013, and
9 ending June 30, 2015.

- 10 1. Each school district shall set aside one high school class period in a required course
11 of the district's choosing, for the purpose of providing instruction in cardiopulmonary
12 resuscitation to as many students as possible. Each nonpublic school shall set aside
13 one high school class period in a required course of the school's choosing, for the
14 purpose of providing instruction in cardiopulmonary resuscitation to as many students
15 as possible. The training must:
- 16 a. Conform to the most recent national evidence-based American heart association
17 guidelines for cardiopulmonary resuscitation and emergency cardiovascular care;
 - 18 b. Be conducted according to guidelines established by the American heart
19 association, the American red cross, or some other nationally recognized
20 nonprofit organization;
 - 21 c. Include the practice of chest compressions; and
 - 22 d. Include instruction in the use of an automated external defibrillator.

- 1 2. a. Upon completion of the training, each school district and nonpublic school may
2 submit to the superintendent of public instruction documentation verifying the
3 training and any expenses incurred in providing the training.
- 4 b. For purposes of this section, "reimbursable expenses" include costs for
5 instructors, training staff as instructors, instructional materials, and training
6 manikins.
- 7 c. A school district's reimbursement may not exceed the equivalent of \$30 multiplied
8 by the number of district students undergoing the training. A nonpublic school's
9 reimbursement may not exceed the equivalent of \$30 multiplied by the number of
10 the school's students undergoing the training.
- 11 3. School districts and nonpublic schools may combine with other school districts and
12 nonpublic schools to provide the training or direct that a regional education association
13 provide or facilitate the training.
- 14 4. The superintendent of public instruction shall provide the reimbursements to school
15 districts and nonpublic schools in accordance with the order in which completed
16 requests are received.
