- 4 Code, relating to compensation and expenses of the Devils Lake outlet management advisory

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 7 SECTION 1. AMENDMENT. Section 61-36-01 of the North Dakota Century Code is amended and reenacted as follows:
 - 61-36-01. Devils Lake outletoutlets management advisory committee Members -Terms - Vacancies.
 - The Devils Lake outletoutlets management advisory committee consists of the stateengineer or the state engineer's designee, one member appointed by the Red Riverjoint water resource board, one member appointed by the Devils Lake joint water resource board, one member appointed by the upper Sheyenne River joint waterresource board, one county commissioner from Ramsey County appointed by the Ramsey County board of county commissioners, one county commissioner from Benson County appointed by the Benson County board of county commissioners, a representative of the Spirit Lake Nation appointed by the tribal council of the Spirit Lake Nation, and three members appointed by the governor. The members appointed by the governor must represent the interests affected by downstream impacts of operating an outlet to Devils Lake. An appointed member may designate a substituteto serve in that person's capacity at such meetings that person may be unable toattend. Except for the first term, all appointed members serve for a term of four years or until their successors are appointed and qualified. For the first term, two of the

2		appointed members must serve two-year terms, provided that at least one member-	
3		representing the interests affected by downstream impacts of operating an outlet to	
4		Dev	rils Lake must remain on the committee for a four-year term. The chairman shall

16		<u>j.</u>	A representative from Valley City appointed by the governor:
17		<u>k.</u>	A representative from Lisbon or Fort Ransom appointed by the governor:
18		<u>l.</u>	A representative from Fargo appointed by the governor:
19		<u>m.</u>	A representative from Grand Forks appointed by the governor:
20		<u>n.</u>	The governor of Minnesota or a designee appointed by the governor of
21			Minnesota;
22		<u>0.</u>	The premier of Manitoba or the premier's designee; and
23		<u>p.</u>	A member of the house and a member of the senate who represent the Devils
24			Lake basin region appointed by the chairman of the legislative management.
25	<u>2.</u>	<u>All a</u>	appointed members serve for a term of four years or until their successors are
26		<u>app</u>	ointed and qualified.
27	<u>3.</u>	Terms expire on the first day of July. Each appointed member must be a qualified	
28		elec	etor of the state and is subject to removal by judicial procedure.
29	<u>4.</u>	The	terms of appointed members must be staggered by lot so that at least three of the
30		<u>tern</u>	ns expire each year.

- 5. Members of the committee may be reappointed for additional terms and except for the
 legislative members, serve at the pleasure of the governor.
 - 6. A vacancy must be filled in the same manner as original appointments for the remainder of the unexpired term. Before entering upon the discharge of official duties, each appointed member shall take, subscribe, and file with the secretary of state the oath prescribed for civil officers.
 - **SECTION 2. AMENDMENT.** Section 61-36-02 of the North Dakota Century Code is amended and reenacted as follows:
 - 61-36-02. Chairman Quorum Meetings.

The state engineergovernor or governor's designee is the chairman of the committee. A majority of the members of the committee constitutes a quorum. The committee mayshall hold meetings at the call of the chairman or at the request of three members before initial operation of the committee outlets, and at such other times and places as the chairman provides deems necessary.

SECTION 3. AMENDMENT. Section 61-36-04 of the North Dakota Century Code is amended and reenacted as follows:

61-36-04. Development of an annual operating planDuties of the committee.

The committee shall develop an annual operating plan for the operation of the Devils Lake outlet. The plan must specify the lake elevation at which pumping will take place. In developing the annual operating plan, the committee shall consider spring runoff forecasts, weather forecasts, summer flooding potential, downstream impacts, including water quality and streambank erosion, flooding, and any other factors the committee determines should be considered. The committee must recommend a plan of operation to the state water commission within two weeks following the first official numeric national weather service spring snowmelt flood outlook. If a majority of members are unable to agree on a plan, one or more minority plans may be submitted to the state water commission. The state water commission may approve, recommend changes, or make changes to the annual operating planadvise the governor and the state water commission regarding operations of all Devils Lake outlets. The committee may recommend criteria for operation of each outlet based on outflow volumes, water quality considerations, and the risk of an overflow of Devils Lake. Any recommendations developed by the committee must receive support from nine of the fifteen members of the

- 1 <u>committee before submission to the governor or state water commission. Any recommendation</u>
- 2 <u>not receiving majority support but receiving support from at least five members may be</u>
- 3 <u>submitted as a minority recommendation</u>.
- 4 **SECTION 4. REPEAL**. Section 61-36-03 of the North Dakota Century Code is repealed.
