- 2 relating to public employees retirement system uniform group insurance coverage of telehealth;
- 3 to require a report regarding coverage of telehealth; and to provide an expiration date.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA: 4

- 5 SECTION 1. Section 54-52.1-04.13 of the North Dakota Century Code is created and 6 enacted as follows:
- 7 54-52.1-04.13. Insurance coverage of telehealth services.
- 8 As used in this section:
- 9 "Distant site" means a site at which a health care provider or health care facility is a. 10 located while providing medical services by means of telehealth.
- 11 "Health care facility" means any office or institution at which health services are b. 12 provided. The term includes hospitals; clinics; ambulatory surgery centers; 13 outpatient care facilities; nursing homes; nursing, basic, long-term, or assisted
 - living facilities; laboratories; and offices of any health care provider.
- "Health care provider" includes an individual licensed under chapter 43-05, <u>C.</u>

43-06, 43-12.1 as a registered nurse or as an advanced practice registered

PUBLIC EMPLOYEES RETIREMENT SYSTEM - COVERAGE OF 12 **TELEHEALTH SERVICES.** Pursuant to section 54-03-28, the public employees retirement 13 system shall prepare and submit for introduction a bill to the sixty-fifth legislative assembly to 14 repeal the expiration date for section 1 of this Act and to extend the coverage of telehealth 15 services to apply to all group and individual health insurance policies. The public employees 16 retirement system shall append to the bill a report regarding the effect of the telehealth 17 coverage requirement on the system's health insurance programs, information on the utilization 18 and costs relating to the coverage, and a recommendation regarding whether the coverage 19 should continue. 20 **SECTION 3. EXPIRATION DATE.** Section 1 of this Act is effective through July 31, 2017, 21 and after that date is ineffective.
