1 A BILL for an Act to amend and reenact subsection 1 of section 57-51.1-07 of the North Dakota

2 Century Code, relating to state water commission use of funding from the resources trust fund;\_\_\_\_\_

3 and to provide an effective date.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Subsection 1 of section 57-51.1-07 of the North Dakota

6 Century Code is amended and reenacted as follows:

- 7 Twenty percent must be allocated and credited to the sinking fund established for 1. 8 payment of the state of North Dakota water development bonds, southwest pipeline 9 series, and any moneys in excess of the sum necessary to maintain the accounts 10 within the sinking fund and for the payment of principal and interest on the bonds must 11 be credited to a special trust fund, to be known as the resources trust fund. The 12 resources trust fund must be established in the state treasury and the funds therein 13 must be deposited and invested as are other state funds to earn the maximum amount 14 permitted by law which income must be deposited in the resources trust fund. Five 15 percent of the amount credited to the resources trust fund must be transferred no less 16 than quarterly into the renewable energy development fund, not to exceed three 17 million dollars per biennium. One-half of one percent of the amount credited to the 18 resources trust fund must be transferred no less than quarterly into the energy 19 conservation grant fund not to exceed one million two hundred thousand dollars per 20 biennium. The principal and income of the resources trust fund may be expended only 21 pursuant to legislative appropriation and are available to:
- a. The state water commission for planning for and construction of water-related
  projects, including rural water systems. These water-related projects must be
  those which the state water commission has the authority to undertake and

4		unless otherwise provided by law andfor planningt be expended may no

7		resource activities, or for water appropriation activities.
8	b.	The industrial commission for the funding of programs for development of
9		renewable energy sources; for studies for development of cogeneration systems
10		that increase the capacity of a system to produce more than one kind of energy
11		from the same fuel; for studies for development of waste products utilization; and
12		for the making of grants and loans in connection therewith.
13	С.	The department of commerce for the funding of programs for development of
14		energy conservation and for the making of grants and loans relating to energy
15		conservation.
16	SECTION	N 2. EFFECTIVE DATE. This Act becomes effective on July 1, 2017.
