- 1 A BILL for an Act to create and enact chapter 23-48 and a new section to chapter 50-24.1 of the
- 2 North Dakota Century Code, relating to the certification of a community health
- 3 worker-community health representative and to medical assistance reimbursement; to provide a
- 4 <u>report; and to provide an effective date</u>.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 SECTION 1. Chapter 23-48 of the North Dakota Century Code is created and enacted as
- 7 follows:

## 8 <u>23-48-01. Definitions.</u>

- 9 <u>The definitions in this section are applicable to this chapter.</u>
- 10 <u>1.</u> <u>"Certified community health worker-community health representative" means a</u>
- 11 <u>community health worker-community health representative who is certified under this</u>
- 12 <u>chapter, applies an understanding of the experience, language, and culture of the</u>
- 13 populations that the individual serves, and provides, as part of a health care team,
- 14 direct services that are aimed at optimizing individual and family health and dental
- 15 <u>outcomes, and which may include:</u>
- 16 <u>a.</u> <u>Informal and motivational counseling and education;</u>
- 17 <u>b.</u> Interventions to maximize social supports:
- 18 <u>c.</u> <u>Participation in care coordination;</u>
- 19 <u>d.</u> <u>Participation in case management;</u>
- 20 <u>e.</u> <u>Facilitation of access to health care, dental care, and social services;</u>
- 21 <u>f.</u> <u>Health and dental screenings; and</u>
- 22 g. Other services as permitted by rule.
- 23 2. <u>"Community health worker-community-health representative" means an individual</u>

6		<u>e.</u>	Helps to improve health outcomes; and	
7		<u>f.</u>	Serves as a critical link between the community in which the individual provides	
8			services and the health care system, thereby reducing health care access	
9			disparities, enhancing health care quality and affordability, and empowering	
10			individuals and communities in the pursuit of better health.	
11	<u>3.</u>	<u>"De</u>	partment" means the state department of health.

13	<u>1.</u>	<u>The</u>	e department shall develop and administer a program to provide for the certification	
14		<u>of c</u>	ommunity health workers-community health representatives.	
15	<u>2.</u>	<u>The</u>	health council shall adopt rules to implement the program. The rules must

17		<u>a.</u>	Education, experience, and training requirements to qualify for certification under	
18			this chapter;	
19		<u>b.</u>	Continuing education standards for certification renewal;	
20		<u>C.</u>	Grounds for certification denial, suspension, revocation, and reinstatement; and	
21		<u>d.</u>	Fees for certification and certification renewal.	
22	<u>3.</u>	<u>The</u>	state health officer may issue a cease-and-desist order to a person violating this	
23		<u>cha</u>	pter or rules adopted under this chapter.	
24	23-48-03. Certified community health worker-community health representative - Use			
25	of designation.			
26	Before an individual practices as, claims to be, or uses a letter designation indicating that			
27	the individual is a certified community health worker-community health representative, the			
28	individual must be certified in accordance with this chapter.			
29	23-48-04. Criminal history record check.			
30	The department shall check or cause to be checked the criminal history record of each			
31	applicant for certification and may check or cause to be checked the criminal history record of

- 1 each applicant for recertification. An applicant who is denied certification based on information
- 2 obtained through a criminal history record check may appeal the denial at the applicant's
- 3 expense.

#### 4 <u>23-48-05. Fees.</u>

- 5 The department shall deposit fees collected under this chapter in the department's
- 6 operating fund.
- 7 <u>23-48-06. Initial certification Waiver of criteria.</u>
- 8 <u>1.</u> An applicant for certification shall submit to the department an application and
   9 associated fees at the time and in the manner required by the department.
- 10 2. The department may waive one or more certification criteria in the case of an
- 11 individual who provides satisfactory evidence of health care training, work experience,
- 12 <u>or other education, comparable to the certification standards required by this chapter.</u>
- 13 <u>3.</u> An individual seeking a waiver of criteria in accordance with subsection 2 shall
- 14 demonstrate familiarity with the community health worker-community health
- representative program in this state and shall agree to limit the individual's practice to
  this state.
- 17 <u>4.</u> <u>A certificate issued under this section is valid for three years.</u>
- 18 <u>23-48-07. Certification Renewal.</u>
- An applicant for certification renewal shall submit to the department an application and associated fees for certification renewal. Each individual is responsible for ensuring that the renewal of certification is completed in a timely manner.
- 2. <u>The department shall issue a renewal certificate that is valid for three years to each</u>
   qualified applicant.
- 24 3. <u>As a condition of certification renewal, the department shall require an applicant to</u>
   25 <u>complete ten hours of approved continuing education each year.</u>
- 26 23-48-08. Certified community health worker-community health representative -

# 27 Scope of practice.

- 28 <u>1.</u> <u>A certified community health worker-community health representative may engage</u>
- 29 <u>only in those activities authorized in this chapter and rules adopted under this chapter.</u>
- 30 While practicing as a certified community health worker-community health

1		representative, an individual may not engage in or perform any act or service for which		
2		another professional certificate, license, or other legal authority is required.		
3	<u>2.</u>	This chapter does not prevent or restrict the practice, service, or activities of any		
4		individual simultaneously certified as a community health worker and licensed,		
5		certified, registered, or otherwise authorized to engage in the practice of another		
6		profession in this state, if that individual does not use, while engaged in the authorized		
7		practice of another profession, any name, title, letter designations, or any other		
8		designation indicating that the individual is a certified community health		
9		worker-community health representative.		
10	SECTION 2. A new section to chapter 50-24.1 of the North Dakota Century Code is created			
11	and enacted as follows:			
12	Medical assistance coverage - Certified community health worker-community health			
13	representative.			
14	Medical assistance coverage must include reimbursement of a certified community health			
15	worker-community health representative, as provided for under chapter 23-48, if the individual			
16	provides for the coordination of care and education services and if the services are provided			
17	under the supervision of a physician, a physician's assistant, a registered nurse, an advanced			
18	practice registered nurse, a behavioral health professional, an optometrist, or a dentist.			
19	SECTION 3. REPORT.			
20	The department of human services shall provide a report to the sixty-fifth legislative			
21	assembly on the medicaid enrollment by community health workers-community health			
22	representatives and on medicaid service utilization of clients receiving services from community			
23	health workers-community health representatives. The department of human services shall			
24	compare medicaid service utilization before and after the medicaid enrollment of community			
25	health workers-community health representatives.
