- 1 A BILL for an Act to create and enact a new section to chapter 57-39.2 of the North Dakota
- 2 Century Code, relating to a sales and use tax exemption for clothing; to provide an-
- 3 appropriation; and to provide an effective date.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:
