- 1 A BILL for an Act to create and enact a new section to chapter 50-11 of the North Dakota
- 2 <u>Century Code, relating to immunity for a person providing foster care for approving reasonable</u>
- 3 and prudent activities; and to amend and reenact section 50-11-00.1 of the North Dakota
- 4 Century Code, relating to definitions used in foster care homes for children and adults.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 SECTION 1. AMENDMENT. Section 50-11-00.1 of the North Dakota Century Code is
- 7 amended and reenacted as follows:

8 **50-11-00.1. Definitions.**

9 As used in this chapter:

- 10 1. "Approval" means the approval by the department of a home of a Native American
- 11 family located on a recognized Indian reservation in North Dakota or of a facility
- 12 owned by the tribe or a tribal member and located on a recognized Indian reservation
- in North Dakota, not subject to the jurisdiction of the state of North Dakota for licensing
 purposes, to allow the home or facility to receive title IV-E funding.
- 15 2. "Authorized agent" means the county social service board, unless another entity is16 designated by the department.
- 17 3. "Department" means the department of human services.
- 4. "Facility" means a family foster home for adults, family foster home for children, group
 home, or residential child care facility for children.
- 20 5. "Family foster home for adults" means an occupied private residence in which foster-
- 21 care for adults is regularly provided by the owner or lessee thereof, to four or fewer-
- adults who are not related by blood or marriage to the owner or lessee, for hire or
 compensation.

- 6. "Family foster home for children" means an occupied private residence in which foster
 care for children is regularly provided by the owner or lessee thereof to no more than
 four children, unless all the children in foster care are related to each other by blood or
 marriage or unless the department approves otherwise for the placement of siblings, in
 which case the limitation in this subsection does not apply.
 7.6. "Foster care for adults" means the provision of food, shelter, security and safety,
- 7 guidance, and comfort on a twenty-four-hour per day basis, in the home of a caregiver,
 8 to a person age eighteen or older, who is unable, neglects, or refuses to provide for
 9 the person's own care.
- 10 8.<u>7.</u> "Foster care for children" means the provision of substitute parental child care for 11 those children who are in need of care for which the child's parent, guardian, or 12 custodian is unable, neglects, or refuses to provide, and includes the provision of food, 13 shelter, security and safety, guidance, and comfort on a twenty-four-hour basis, to one 14 or more children under twenty-one years of age to safeguard the child's growth and 15 development and to minimize and counteract hazards to the child's emotional health 16 inherent in the separation from the child's family. Foster care may be provided in a 17 family foster home, group home, or residential child care facility.
- 8. "Foster home for adults" means an occupied private residence in which foster care for
 adults is regularly provided by the owner or lessee of the residence, to four or fewer
 adults who are not related by blood or marriage to the owner or lessee, for hire or
 compensation.
- 9. "Group home" means a <u>licensed or approved</u> residence in which foster care is
 regularly provided for more than four, but <u>lessfewer</u> than <u>tenthirteen</u>, unrelated
 children.
- 10. "Residential child care facility" means a <u>licensed or approved</u> facility other than an
 occupied private residence providing foster care to more than eight<u>thirteen or more</u>
 unrelated children, except as may be otherwise provided by rule or regulation.
 SECTION 2. A new section to chapter 50-11 of the North Dakota Century Code is created

and enacted as follows:

1	Immunity for a person providing foster care.
2	A person providing foster care for children in a licensed or approved facility is immune from
3	civil liability for any act or omission resulting in damage or injury to or by a child in foster care if,
4	at the time of the act or omission, the person providing foster care for children applied the
5	reasonable and prudent parent standard in a manner that protects child safety, while also
6	allowing the child in foster care to experience age or developmentally appropriate activities.
