This bill directs the Adjutant General to initiate and coordinate the collection of information on North Dakotans who served in a theatre or area of armed conflict since the Vietnam conflict and make it available for use in and the publishing of the book of veterans.

The fiscal impact to collect this data is estimated at \$50,000.
