1 A BILL ~~for an Act to create and enact a new subdivision to section 2 of section 62.1-04-03 of the~~
 2 ~~North Dakota Century Code, relating to carrying a concealed weapon~~ for an Act to create and
 3 enact a new subdivision to subsection 2 of section 62.1-02-05 and a new subdivision to
 4 subsection 2 of section 62.1-04-03 of the North Dakota Century Code, relating to possessing a
 5 firearm or dangerous weapon at a public gathering and licenses to carry concealed weapons; to
 6 amend and reenact subdivision a of subsection 6 of section 62.1-02-13 of the North Dakota
 7 Century Code, relating to possessing a secured firearm; to provide a penalty; and to declare an
 8 emergency.

9 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

10 ~~SECTION 1. A new subdivision to subsection 2 of section 62.1-04-03 of the North Dakota~~
 11 ~~Century Code is created and enacted as follows:~~

12 ~~A North Dakota resident who has a valid class 2 firearm license may obtain a~~
 13 ~~class 1 firearm license upon successful completion of the actual shooting or~~
 14 ~~certified proficiency exercise required under subdivision a.~~

15 **SECTION 1.** A new subdivision to subsection 2 of section 62.1-02-05 of the North Dakota
 16 Century Code is created and enacted as follows:

17 An individual who resides in and stores a firearm or dangerous weapon in a
 18 residential dwelling located on school property.

19 **SECTION 2. AMENDMENT.** Subdivision a of subsection 6 of section 62.1-02-13 of the
 20 North Dakota Century Code is amended and reenacted as follows:

21 a. Any ~~public or nonpublic elementary school, middle school, or high school~~
 22 property, except parking lots, within the perimeter of the school site and all school

1 buildings, structures, facilities, and school vehicles, whether owned or leased by a
2 school district, and the site of any school-sponsored activity.

3 **SECTION 3.** A new subdivision to subsection 2 of section 62.1-04-03 of the North Dakota
4 Century Code is created and enacted as follows:

5 An individual who has a valid class 2 firearm license may apply to upgrade to a
6 class 1 firearm license within five years from the date the class 2 firearm license
7 was issued and upon successful completion of the requirements under
8 subdivision a. An individual who has a valid class 1 firearm license may request
9 to convert the license to a class 2 firearm license before the expiration of the
10 class 1 firearm license.

11 **SECTION 4. EMERGENCY.** This Act is declared to be an emergency measure.
