Appropriations Committee

- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
- 2 governor; and to amend and reenact section 54-07-04 of the North Dakota Century Code,
- 3 relating to the salary of the governor; to provide for a legislative management report; to provide
- 4 for retroactive application; to provide a contingent expiration date; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying the expenses of the office of the governor, for the biennium beginning July 1, 2017, and ending June 30, 2019, as follows:

SECTION 2. HEALTH INSURANCE INCREASE. The salaries and wages line item in section 1 of this Act includes the sum of \$50,086\$46,457 from the general fund for increases in employee health insurance premiums from \$1,130 to \$1,249\$1,241 per month.

SECTION 3. ONE-TIME FUNDING. The following amounts reflect the one-time funding items approved by the sixty-fourth legislative assembly as adjusted for the 2015-17 biennium:

SECTION 4. APPROPRIATION - GOVERNOR'S OFFICE - LEGISLATIVE MANAGEMENT

REPORT. In addition to the amounts appropriated to the governor's office in section 1 of this Act, there is appropriated to the governor's office, any additional income from federal or other funds which may become available to the governor's office, for the biennium beginning July 1, 2017, and ending June 30, 2019. Any funds received under this section must be used for the specific purpose intended for the funds or transferred to the appropriate state agency or institution. Upon the receipt of funds under this section, the governor's office shall provide a report to the legislative management regarding the source, amount, and purpose of the funds received.

SECTION 5. GOVERNOR'S SALARY AND FRINGE BENEFIT FUNDING. The salaries and wages line item in section 1 of this Act includes the sum of \$347,424 from the general fund which may only be used for salary and fringe benefit payments to the governor during the biennium beginning July 1, 2017, and ending June 30, 2019. Any portion of this sum which is not used for salary and fringe benefit payments to the governor must be canceled at the end of the biennium pursuant to section 54-44.1-11.

SECTION 6. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is amended and reenacted as follows:

54-07-04. Salary of governor.

The annual salary of the governor is one hundred twenty-nine thousand ninety-one dollars through June 30, 2016, and one hundred thirty-two thousand nine hundred sixty-four dollars thereafterone dollar.

1	SECTION 7. RETROACTIVE APPLICATION. Section 6 of this Act applies retroactively to
2	December 15, 2016.
3	SECTION 8. CONTINGENT EXPIRATION DATE. Section 6 of this Act is effective until the
4	secretary of state notifies the legislative council that an individual who did not hold the office of
5	governor as of December 15, 2016, has filed an oath of office to assume the office of governor,
6	or until December 14, 2020, whichever date is earlier.
7	SECTION 9. EMERGENCY. Sections 6, 7, and 8 of this Act are declared to be an
8	emergency measure.
