1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of  
2 transportation; and to provide for a transfer.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated from special funds derived from federal funds and other  
6 income, to the department of transportation for the purpose of defraying the expenses of the  
7 department of transportation, for the biennium beginning July 1, 2017, and ending June 30,  
8 2019, as follows:

8       **SECTION 3. LINE ITEM TRANSFERS.** The director of the department of transportation  
9 may transfer between the salaries and wages, operating, capital assets, and grants line items in  
10 section 1 of this Act when it is cost-effective for construction and maintenance of highways. The  
11 department of transportation shall notify the office of management and budget of any transfers  
12 made pursuant to this section.
