1 A BILL for an Act to provide an appropriation for defraying the expenses of the comprehensive-

2 tobacco control advisory committee. for an Act to amend and reenact subsection 2 of section

3 23-12-10.4, subsection 2 of section 54-27-25, and subsection 1 of section 54-59-22.1 of the

4 North Dakota Century Code, relating to smoking prohibited signage, the tobacco settlement

5 trust fund, and required use of centralized desktop support services; to repeal chapter 23-42 of

6 the North Dakota Century Code, relating to the tobacco prevention and control program; to

7 provide an effective date; and to declare an emergency.

## 8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

9 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds-

10 as may be necessary, are appropriated out of any moneys in the tobacco prevention and control

11 trust fund, not otherwise appropriated, to the comprehensive tobacco control advisory-

12 committee for the purpose of defraying the expenses of the committee, for the biennium-

13 beginning July 1, 2017, and ending June 30, 2019, as follows:
