- 2 chapter 15.1-21, and a new section to chapter 54-06 of the North Dakota Century Code, relating
- 3 to the authority of the superintendent of public instruction and other state officials and agencies.
- 4 and to standards and assessments; to amend and reenact sections 15.1-02-04 and 15.1-21-12
- 5 of the North Dakota Century Code, relating to the duties of the superintendent of public
- 6 instruction and professional development; to repeal sections 15.1-21-08, 15.1-21-09,

- 8 assessments; to provide an effective date; and to declare an emergency.

## 9 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 10 **SECTION 1. AMENDMENT.** Section 15.1-02-04 of the North Dakota Century Code is
- 11 amended and reenacted as follows:
- 12 **15.1-02-04.** Superintendent of public instruction Duties.
- 13 The superintendent of public instruction:
- 1. Shall supervise the provision of elementary and secondary education to the students of this state.;
- Shall supervise the establishment and maintenance of schools and provide advice and
  counsel regarding the welfare of the schools-;
- 18 3. Shall supervise participate in the development of course content standards.
- 4. Shall supervise the assessment of students:
- 5. Shall serve as an ex officio member of the board of university and school lands.

5	SECTION 2. A new section to chapter 15.1-02 of the North Dakota Century Code is created

8	<u>1.</u>	Without statutory authorization by the legislative assembly, the superintendent of				
9		public instruction may not adopt, align to, implement, or be a signatory to any				
10		document that adopts, aligns, implements, or commits this state or any school district				
11		to participate, at any level, in any national or multistate consortium course content				
12		standards from any source or require the use of any assessments aligned with any				
13		national or multistate consortium course content standards from any source that cedes				
14		to the national or multistate consortium control of North Dakota educational course				
15		content standards in any manner, including course content standards in mathematics,				

Without statutory authority by the legislative assembly, the superintendent of public instruction may not implement new statewide course content standards. If the superintendent of public instruction adopts or revises course content standards under this section, the course content standards must be developed independent of any national or multistate consortium.

**SECTION 3. AMENDMENT.** Section 15.1-21-12 of the North Dakota Century Code is amended and reenacted as follows:

## 15.1-21-12. Professional development - Use of available funds.

- 1. On or before October first of each year, each school district shall file a report with the superintendent of public instruction indicating:
  - The amount and source of funds that were made available to the district for professional development during the preceding school year;
  - b. The amount and source of funds that were expended by the district for professional development during the preceding school year; and

- c. A separate list of the professional development activities in which the district
  participated during the preceding school year and the amount of time committed
  to the activities.
  The superintendent of public instruction shall compile the information submitted under
  - 2. The superintendent of public instruction shall compile the information submitted under this section to determine how much of the available funding for professional development was used by school districts in this state and, beginning with the reports-due on or before October 1, 2002, whether the expenditure correlated with increased student achievement on the reading and mathematics tests required by section 15.1-21-08.
  - **SECTION 4.** A new section to chapter 15.1-21 of the North Dakota Century Code is created and enacted as follows:

# Withdrawal from assessment consortiums.

On the effective date of this Act, the state shall retain sole control over the development, establishment, and revision of course content standards for grades kindergarten through twelve. The state shall terminate all plans, programs, activities, efforts, and expenditures relating to the implementation of the educational initiative commonly referred to as the common core course content standards, or any derivative or permutation of that educational initiative including, any assessments, data collection, or instructions based on or involving that educational initiative. As part of the process of conversion from the common core course content standards, the superintendent of public instruction and any other state agency or employee shall takes steps necessary to terminate areas of federal control over the North Dakota educational process.

**SECTION 5.** A new section to chapter 15.1-21 of the North Dakota Century Code is created and enacted as follows:

## Interim standards and assessments.

- 1. The superintendent of public instruction shall:
  - a. Respect and support the right of a parent to opt a child of the parent out of public school and any activity, practice, or testing, with no interference from the state, which the parent finds unacceptable or to which the parent has a philosophical, moral, or religious objection. This subdivision does not prohibit the state from funding public education of a per-pupil basis.

4		a. Establish a fundamental academic curriculum for students at the elementary,			
5		middle, and secondary education level. The fundamental academic curriculum			
6		must define academic objectives to be achieved by all pupils and must be based			
7		on the school district's educational mission, long-term student educational goals,			
8		and student performance objectives.			
9		b. Determine the aligned instructional program for delivering the school district's			
10		fundamental academic curriculum and identify the courses and programs in			
11		which the fundamental academic curriculum will be taught, after consulting with			
12		teachers and school district administrators.			
13		c. Provide adequate time and transparency, of no less than thirty days, for public			
14		review and comment on the aligned instructional programs by all interested			
15		members of the community before final review.			
16	<u>3.</u>	This section may not be construed to promote any religious or nonreligious doctrine,			
17		promote discrimination for or against a particular set of religious beliefs or nonbeliefs,			
18		or promote discrimination for or against religion or nonreligion.			
19	<u>4.</u>	The superintendent of public instruction may not adopt or implement new course			
20		content standards that are distinct from the course content standards adopted in			
21		subsection 1 for at least five years after the effective date of this Act.			
22	SECTION 6. A new section to chapter 54-06 of the North Dakota Century Code is created				
23	and ena	cted as follows:			
24	Use of state resources - Prohibition.				
25	Starting with the 2017-18 school year, no state official or agency may directly or indirectly				
26	utilize state resources in support of or in advancement of:

- 3 **SECTION 7. REPEAL.** Sections 15.1-21-08, 15.1-21-09, 15.1-21-10, 15.1-21-11, and
- 4 15.1-21-14 of the North Dakota Century Code are repealed.
- 5 **SECTION 8. EFFECTIVE DATE.** This Act becomes effective on July 1, 2017.
- 6 **SECTION 9. EMERGENCY.** This Act is declared to be an emergency measure.
