4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from the strategic investment and improvements fund to the state treasurer for the purpose of defraying the expenses of the state treasurer, for the biennium beginning July 1, 2019, and ending June 30,

The state treasurer shall report to the appropriations committees of 10 the sixty-seventh legislative assembly on the use of this one-time funding for the biennium 11 beginning July 1, 2019, and ending June 30, 2021. 12 SECTION 3. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS 13 FUND. The operating expenses line item and the estimated income line item in section 1 of this 14 Act include \$35,000 from the strategic investment and improvements fund for information 15 technology costs. 16 **SECTION 4. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is 17 amended and reenacted as follows: 18 54-11-13. Salary of state treasurer. 19 The annual salary of the state treasurer is ninety-six thousand nine hundred seventy-two-20 dollars through June 30, 2016, and ninety-nine thousand eight hundred eighty-one dollars-21 thereafterone hundred seven thousand eight hundred eighty-fiveone hundred one thousand 22 eight hundred seventy-nine dollars through June 30, 2020, and one hundred eleven thousand-23 one hundred twenty-two one hundred four thousand four hundred twenty-six dollars thereafter.
