## **ENGROSSED SENATE BILL NO. 2320**

- 1 A BILL for an Act to create and enact chapter 15-10.4 of the North Dakota Century Code,
- 2 relating to free speech at institutions under the control of the state board of higher education.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Chapter 15-10.4 of the North Dakota Century Code is created and enacted as
follows:

## 6 <u>15-10.4-01. Definitions.</u>

7 <u>As used in this chapter:</u>

- 8 <u>1.</u> "Constitutional time, place, and manner restrictions" means restrictions on the time,
- 9 place, and manner of free speech which do not violate the First Amendment to the
- 10 <u>United States Constitution or section 4 of article I of the Constitution of North Dakota</u>
- 11 and which are reasonable, content- and viewpoint-neutral, and narrowly tailored to
- satisfy a significant institutional interest, and leave open alternative channels for the
   communication of the information or message.
- 14 <u>2.</u> "Faculty" means an individual, regardless of whether the individual is compensated by
   an institution, and regardless of political affiliation, who is tasked with providing
- 16 scholarship, academic research, or teaching, including tenured and nontenured
- 17 professors, adjunct professors, visiting professors, lecturers, graduate student
- 18 instructors, and those in comparable positions. "Faculty" does not mean an individual
- whose primary responsibilities are administrative or managerial, unless the individual
  also teaches at least one credit-hour.
- 21 <u>3.</u> <u>"Free speech" means speech, expression, and assemblies protected by the First</u>
- 22 Amendment to the United States Constitution or section 4 of article I of the
- 23 <u>Constitution of North Dakota, including all forms of peaceful assembly, protests,</u>
- 24 demonstrations, rallies, vigils, marches, public speaking, distribution of printed

1		materials, carrying signs, displays, or circulating petitions. "Free speech" does not
2		include the promotion, sale, or distribution of a product or service, unless the
3		promotion, sale, or distribution of the product or service is incidental to the exercise of
4		free speech.
5	<u>4.</u>	"Institution" means an institution under the control of the state board of higher
6		education.
7	<u>5.</u>	"Student" means an individual enrolled in at least one course offered by an institution.
8	<u>6.</u>	"Student organization" means an officially recognized organization at an institution, or
9		an organization seeking official recognition, comprised of admitted students receiving
10		or are seeking to receive benefits through the institution.
11 <u>15-10.4-02. Adoption of campus free speech policy.</u>		
12 The state board of higher education and each institution shall adopt a policy that:		
13	<u>1.</u>	Protects students' rights to free speech, assembly, and expression;
14	<u>2.</u>	Permits institutions to establish and enforce reasonable and constitutional time, place,
15		and manner restrictions on free speech, assembly, and expression;
16	<u>3.</u>	Permits students, faculty, or student organizations to invite guest speakers or groups
17		to present regardless of the viewpoint or content of the anticipated speech of the guest
18		speaker or group; and
19	<u>4.</u>	Protects the academic freedom and free speech rights of faculty while adhering to
20		guidelines established by the American association of university professors.
