25	SECTION 2. LEGISLATIVE INTENT - COST REIMBURSEMENTS - LOAN		
26	REPAYMENTS. It is the intent of the sixty-sixth legislative assembly that the attorney general		
27	seek reimbursement from the federal government for the costs of responding to unlawful activity		
28	associated with the construction of the Dakota access pipeline. It is further the intent of the		
29	sixty-sixth legislative assembly that these reimbursements be used to repay the Bank of North		
30	Dakota loans authorized by the emergency commission and the legislative assembly which		
31	were obtained to provide the funding necessary to respond to the unlawful activity associated

- 1 with the construction of the Dakota access pipeline. It is further the intent of the sixty-sixth
- 2 legislative assembly that the provisions of section 54-16-13 apply to the loans, except that
- 3 emergency commission approval does not apply.
- 4 **SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
