21	SECTION 2. LEGISLATIVE MANAGEMENT STUDY - MEDICAL MARIJUANA			
22	<b>DEBILITATING MEDICAL CONDITIONS.</b> During the 2019-20 interim, the legislative			
23	management shall consider studying the list of debilitating medical conditions under the medical			
24	marijuana program to determine the appropriateness of the list, including whether conditions			
25	should be added to or removed from the list. The legislative management shall report its			
26	findings and recommendations, together with any legislation necessary to implement the			
27	recommendations, to the sixty-seventh legislative assembly.			
28	SECTION 3. EMERGENCY. This Act is declared to be an emergency measure.
