ENGROSSED SENATE BILL NO. 2006

1 A BILL for an Act to provide an appropriation for defraying the expenses of the North Dakota
2 aeronautics commission; to provide for a report; and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and
7 other income, to the North Dakota aeronautics commission for the purpose of defraying the
8 expenses of the North Dakota aeronautics commission, for the biennium beginning July 1,
9 2021, and ending June 30, 2023, as follows:

19 **SECTION 2. ONE-TIME FUNDING EFFECT ON BASE BUDGET - REPORT TO THE**

20 **SIXTY-EIGHTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding

21 items approved by the sixty-sixth legislative assembly for the 2019-21 biennium and the

22 2021-23 one-time funding items included in the appropriation in section 1 of this Act:

4 The 2021-23 biennium one-time funding amounts are not a part of the entity's base budget
5 for the 2023-25 biennium. The aeronautics commission shall report to the appropriation
6 committees of the sixty-eighth legislative assembly on the use of this one-time funding for the
7 biennium beginning July 1, 2021, and ending June 30, 2023.

8 **SECTION 3. ESTIMATED INCOME - AIRPORT INFRASTRUCTURE FUND - AIRPORT**

9 **GRANTS - EXEMPTION.** The estimated income line item in section 1 of this Act includes
10 \$20,000,000 from the airport infrastructure fund for the aeronautics commission to provide
11 grants to airports during the biennium beginning July 1, 2021, and ending June 30, 2023.
12 Section 54-44.1-11 does not apply to this funding, and any additional funds not spent by
13 June 30, 2023, must be continued into the biennium beginning July 1, 2023, and ending
14 June 30, 2025, and may be expended only for providing grants to airports.

15 **SECTION 4. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS**

16 **FUND.** The estimated income line item in section 1 of this Act includes \$5,000,000 from the
17 strategic investment and improvements fund for airport grant.
