HB 1246 would eliminate the deduction of tuition as an in lieu of property tax for tuition received under an agreement to education students with funding received through impact aid.

Section 1 would eliminate the deduction from in lieu of property taxes for tuition that is received from the Minot and Grand Forks Base school districts. These districts are funded through federal impact aid and that money is paid to neighboring districts to educate students that are residents of the Air Force Base.

Base school districts pay \$10.7 million dollars per year in tuition to public school districts. The deduct for in lieu of property taxes for this tuition is \$14.3 million for the biennium. This would increase the amount of state aid sent to districts that educate students that are residents of the base.
