Engrossed SB 2156 raises the minimum legal age to purchase, possess or use tobacco products from eighteen to twenty-one.

If enacted, Engrossed SB 2156 will increase the minimum legal age (MLA) for purchasing, possessing, and using all tobacco products to age twenty-one. Studies indicate that over ten percent of high school students are daily or occasional smokers. If this bill is enacted, some of the consumption of tobacco products by these individuals will cease, and some young people may delay smoking for up to three years.

Assuming 1100 young adults stop or delay purchasing cigarettes in the state, each consuming an average of 1.5 fewer packages per week, there would be an estimated drop in wholesale cigarette tax of \$76,000 for the 2021-23 biennium. Engrossed SB 2156 includes an emergency provision indicating it could become effective immediately resulting in a possible slight impact in the current, 2019-21 biennium as well.
