SB2161 establishes and maintains a registry of mental health providers in the state and also establishes and maintains a behavioral health bed management system for public and private providers.

Section 1 of SB2161 would have a one time cost \$15,000 to establish and maintain the registry of mental health providers on the Department of Human Services website.

Section 2 of SB2161 would have a one time cost of \$29,250 to implement a behavioral health bed management system. It would also require a monthly maintenance and operating cost of \$1,250/month or \$30,000 per biennium. This bed management system is estimated to be implemented by 7/1/2022.

For the 2021-2023 biennium the Department of Human Services would have an increase of \$15,000 for the mental health provider registry and \$44,250 for the one time implementation and one year of monthly maintenance and operation costs of the bed management system.

For the 2023-2025 biennium the Department of Human Services would need an increase of \$30,000 for the bed management system.

For the 2023-2025 biennium the Department of Human Services would require an increased general fund appropriation of \$30,000 for the bed management system.
