The bill provides for reimbursement of reasonable attorneys fees and costs incurred by a state employee in successfully defending a criminal investigation or prosecution involving actions taken as a state employee.

Payments for reasonable attorneys fees and costs incurred by a state employee in successfully defending a criminal investigation or prosecution would come from the Risk Management Fund administered by OMB-Risk Management pursuant to NDCC chap. 32-12.2. Criminal investigations or prosecutions of state employees for actions taken within the scope of employment are infrequent and difficult to predict with any meaningful degree of certainty. This bill is retroactive to criminal investigations occurring after January 1, 2019, and it is known there are claims for attorneys fees and costs that currently fit within the parameters of this bill in the amount of \$48,136.
