SB 2310 modifies the charitable gaming and tribal-state gaming compacts, creates a new section relating to the regulation of electronic pull tab devices, and limits the number of electronic pull tab devices.

This bill will limit the number of electronic pull tab devices to 2,300. This would be a decrease of 921 from our current device count of 3,221. We estimate a general fund reduction of 6,604,568. This bill does not allow a bar employee to redeem an electronic pull tab credit ticket voucher and this may decrease the number of locations a charity would place a device due to increased staffing. The max prize per ticket would change from \$500 per line to \$500 per ticket. The gaming commission would go from 5 members to 10.
