1 A BILL for an Act to provide an appropriation to the state board of higher education for the

## 10 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$20,000,000\$21,500,000, or so much of the sum as may be necessary, to the state board of higher education for the purpose of awarding matching grants for student scholarships and the advancement of academics at institutions under the control of the board of higher education, for the biennium beginning July 1, 2021, and ending June 30, 2023. The funding provided in this section is considered a one-time funding item.

18 SECTION 2. Paragraph 3 of subdivision b of subsection 1 of section 15-10-48 of the North
19 Dakota Century Code is created and enacted as follows:
