Sixty-seventh Legislative Assembly of North Dakota In Regular Session Commencing Tuesday, January 5, 2021

HOUSE BILL NO. 1105 (Representatives Dobervich, P. Anderson, Buffalo, Hanson, Pyle) (Senators Bakke, Heckaman, Hogan, Mathern, Oban)

AN ACT to amend and reenact sections 12.1-20-12.1 and 23-12-16 of the North Dakota Century Code, relating to breastfeeding; and to provide a penalty.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 12.1-20-12.1 of the North Dakota Century Code is amended and reenacted as follows:

12.1-20-12.1. Indecent exposure.

- 1. A personAn individual, with intent to arouse, appeal to, or gratify that person's individual's lust, passions, or sexual desires, is guilty of a class A misdemeanor if that personindividual:
 - a. Masturbates in a public place or in the presence of a minor;
 - b. Exposes one's the individual's penis, vulva, or anus in a public place or to a minor in a public or private place;
 - c. Exposes one's the individual's penis, vulva, or anus by unsolicited electronic means; or
 - d. Exposes one's the individual's penis, vulva, or anus by any electronic means to a minor.
- 2. A personAn individual is guilty of a class C felony if the personindividual violates subsection 1 after a previous conviction for violating subsection 1, after a previous conviction for violating section 12.1-20-12.2, or after being required to register under section 12.1-32-15.
- 3. A personAn individual who commits a violation of subdivision a or b of subsection 1 within fifty feet [15.24 meters] of or on the real property comprising a public or nonpublic elementary, middle, or high school is guilty of a class C felony. A personAn individual who commits a violation of subsection 2 within fifty feet [15.24 meters] of or on the real property comprising a public or nonpublic elementary, middle, or high school is guilty of a class B felony.
- 4. The act of a woman discreetly breastfeeding her child is not a violation of this section.
- 5. As used in this section, "electronic means" includes images and pictures transmitted via electronic mail, electronic messaging, or from an electronic communications device.

SECTION 2. AMENDMENT. Section 23-12-16 of the North Dakota Century Code is amended and reenacted as follows:

23-12-16. Right to breastfeed.

If the woman acts in a discreet and modest manner, a woman may breastfeed her child in any location, public or private, where the woman and child are otherwise authorized to be.
