1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the

2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota

3 <u>Century Code, relating to the salaries of the governor and lieutenant governor; to provide an</u>

4 <u>exemption;</u> to provide for a report<u>;</u> and to declare an emergency.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds 7 as may be necessary, are appropriated out of any moneys in the general fund in the state 8 treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying 9 the expenses of the office of the governor, for the biennium beginning July 1, 2021, and ending 10 June 30, 2023, as follows:

11 SECTION 3. ADDITIONAL INCOME - APPROPRIATION - GOVERNOR'S OFFICE -

12 **BUDGET SECTION REPORT.** In addition to the amounts appropriated in section 1 of this Act,

13 there is appropriated to the governor's office, any additional income from federal or other funds

14 which may become available to the governor's office, for the biennium beginning July 1, 2021,

15 and ending June 30, 2023. Any funds received under this section must be used for the specific

16 purpose intended for the funds or transferred to the appropriate state agency or institution.

Upon the receipt of funds under this section, the governor's office shall provide a report to the
budget section regarding the source, amount, and purpose of the funds received.

- SECTION 4. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is
 amended and reenacted as follows:
 - 54-07-04. Salary of governor.

The annual salary of the governor is one hundred thirty-fiveforty thousand three eight

23 hundred sixty-fourtwenty-nine dollars through June 30, 20202022, and one hundred thirty-

24 eightforty-two thousand sevennine hundred forty-eightforty-one dollars thereafter.

SECTION 5. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is
 amended and reenacted as follows:

27 **54-08-03. Salary of lieutenant governor.**

28 The annual salary of the lieutenant governor is one hundred fivenine thousand twofive

29 hundred eighty-fivethirty-six dollars through June 30, 2020202, and one hundred seven eleven

30 thousand <u>nineone</u> hundred <u>seventeenseventy-nine</u> dollars thereafter.

1	SECTION 6. EXEMPTION - LINE ITEM TRANSFERS - 2019-21 BIENNIUM.	
2	Notwithstanding section 54-16-04, the office of management and budget may transfer up to	
3	\$64,242 of appropriation authority from the operating expenses line item to the salaries and	
4	wages line item in section 1 of chapter 26 of the 2019 session laws as requested by the	
5	governor.	
6	SECTION 7. EXEMPTION. The funding appropriated in the rough rider awards line item in	
7	section 1 of chapter 26 of the 2019 session laws is not subject to the provisions of section	
8	54-44.1-11 and may be continued into the biennium beginning July 1, 2021, and ending	
9	June 30, 2023.	
10	SECTION 8. EMERGENCY. Section 6 of this Act is declared to be an emergency measure.
