

**FIRST ENGROSSMENT  
with House Amendments  
ENGROSSED SENATE BILL NO. 2011**

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the highway patrol;  
2 to provide a report; to provide for a transfer; to provide an exemption; and to declare an  
3 emergency.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated out of any moneys in the general fund in the state  
7 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
8 other income, to the highway patrol for the purpose of defraying the expenses of the highway  
9 patrol, for the biennium beginning July 1, 2021, and ending June 30, 2023, as follows:

17 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**  
18 **SIXTY-EIGHTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
19 items approved by the sixty-sixth legislative assembly for the 2019-21 biennium and the  
20 one-time funding items included in the appropriation in section 1 of this Act:

7       The 2021-23 biennium one-time funding amounts are not a part of the entity's base budget  
8 for the 2023-25 biennium. The highway patrol shall report to the appropriations committees of  
9 the sixty-eighth legislative assembly on the use of this one-time funding for the biennium  
10 beginning July 1, 2021, and ending June 30, 2023.

11       **SECTION 3. APPROPRIATION - 2019-21 BIENNIUM - FEDERAL CORONAVIRUS**

12 **RELIEF FUND - SPENDING RESTRICTION.** There is appropriated from federal funds derived  
13 from the federal coronavirus relief fund, not otherwise appropriated, the sum of \$8,100,000, or  
14 so much of the sum as may be necessary, to the highway patrol for law enforcement officer  
15 payroll costs for the period beginning January 1, 2021, and ending June 30, 2021. The funding  
16 appropriated in this section replaces existing legislative appropriations. The highway patrol may  
17 not spend the funding appropriated from the general fund and highway tax distribution fund for  
18 law enforcement payroll costs during the period identified.

19       **SECTION 4. ESTIMATED INCOME - FEDERAL CORONAVIRUS RELIEF FUND.** The  
20 estimated income line item in section 1 of this Act includes the sum of \$8,100,000, or so much  
21 of the sum as may be necessary, from the federal coronavirus relief fund for law enforcement  
22 officer payroll costs for the period beginning July 1, 2021, and ending December 31, 2021.

23       **SECTION 5. ESTIMATED INCOME - TRANSFER - HIGHWAY TAX DISTRIBUTION FUND.**

24 The estimated income line item in section 1 of this Act includes the sum of \$7,376,374, or so  
25 much of the sum as may be necessary, from the state highway tax distribution fund which may  
26 be transferred at the direction of the superintendent of the highway patrol for defraying the  
27 expenses of the highway patrol during the biennium beginning July 1, 2021, and ending  
28 June 30, 2023.

29       **SECTION 6. ESTIMATED INCOME - MOTOR CARRIER ELECTRONIC PERMIT**

30 **TRANSACTION FUND.** The estimated income line item in section 1 of this Act includes  
31 \$3,147,244 from the motor carrier electronic permit transaction fund for defraying various

1 expenses associated with the issuance of permits and other nonenforcement motor carrier and  
2 administrative activities.

3 **SECTION 7. SALARY EQUITY FUNDING.** Section 1 of this Act includes the sum of  
4 \$872,093 for salary equity funding. This amount, along with any funding available from agency  
5 operational savings that may be reallocated, may be used for:

- 6 1. Salary equity adjustments that may not exceed \$1,125,000 in total for the biennium;
- 7 2. Law enforcement officer on-call pay that may not exceed 25 percent of the officer's  
8 hourly salary for regular on-call duties and may not exceed 50 percent of the officer's  
9 hourly salary for emergency on-call duties; and
- 10 3. Location incentive pay based on existing agency policies.

11 **SECTION 8. EXEMPTION.** The sum of \$50,530 from the general fund appropriated in  
12 section 1 of chapter 11 of the 2019 Session Laws is not subject to section 54-44.1-11 and may  
13 be continued into the biennium beginning July 1, 2021, and ending June 30, 2023.

14 **SECTION 9. PAYMENTS TO HIGHWAY PATROL OFFICERS.** Each patrol officer of the  
15 state highway patrol is entitled to receive from funds appropriated in section 1 of this Act an  
16 amount not to exceed \$200 per month for the biennium beginning July 1, 2021, and ending  
17 June 30, 2023. The payments are in lieu of reimbursement for meals and other expenses,  
18 except lodging, while in travel status within the state of North Dakota or while at the patrol  
19 officers' respective home stations. The amounts must be paid at the time and in the same  
20 manner as salaries are paid to members of the highway patrol and may be paid without the  
21 presentation of receipts or other memorandums.

22 **SECTION 10. EMERGENCY.** Section 3 of this Act is declared to be an emergency  
23 measure.
