HB 1475 creates the agriculture diversification and development fund to provide loans, interest rate buydowns and grants from the fund to support new or expanded value-added agriculture businesses.

Section 4 of HB 1475 transfers \$10,000,000 from the general fund to the agriculture development and diversification fund. The funds are appropriated, on a continuing basis, for loan disbursements, grants and administrative costs pursuant to Section 1 of HB 1475. No more than 25% of the fund may be utilized for grants in a biennium.

There is no effect on revenues. The agriculture diversification and development fund proposed in HB 1475 is a revolving loan fund, administered by BND.

The proposed agriculture diversification and development fund will be under the administration of BND. While this program alone will not require a FTE, as the administered loan programs grow and expand, there will be additional FTE positions required at BND.

The appropriation of \$10,000,000 is a transfer from the general fund to the agriculture diversification and development fund. HB 1475 proposes the agriculture diversification and development fund have a continuing appropriation enabling Bank of North Dakota, in consultation with the agriculture diversification and development committee, to develop policies for loans, interest rate buydowns or grants. The agriculture diversification and development fund is a revolving loan fund administered by BND.
