POINT OF PERSONAL PRIVILEGE

SEN. WOBBEMA rose on a point of personal privilege.

REMARKS OF SENATOR WOBBEMA

MR. PRESIDENT: Before I really begin, I would like to say Happy Birthday to the United States Marine Corps. They celebrated their 246th birthday yesterday. – Hoorah!

It is with pride, and humble appreciation that I rise before this body today to speak about Veterans Day. With pride, because I am fortunate enough to call myself a Veteran, with humble appreciation to have been blessed by our Creator to have been born in this great nation; but more importantly, to be able, in this chamber, to honor those who have made service to this nation's citizens through military service to our country, an act that extends well beyond that of any other type of service to their fellow man.

On this day, we celebrate the service of those who belong to this great family we call the military. Whether Army, Navy, Air Force, Marine Corps or Coast Guard; active duty, reserve or national guard, those who have served deserve recognition. From freezing in Valley Forge, patrolling the steamy jungles of Vietnam; from Korea to Kuwait to Kandahar; to Africa, Asia, Central America, South America or Europe, our Veterans have carried the burden of the true cost of what it means to be an American on their shoulders.

What makes this such a close-knit family? What is the connection? It is the common bond that comes from understanding what the shared challenges, shared frustrations, shared pain, and shared joy is. Regardless of branch of service, there is an understanding of what each other has gone through, along with the knowledge of what each other is yet willing to go through. A sense of purpose, mission if you will. A developed and ingrained warrior ethos that becomes part of every person who has put on the uniform; and never leaves them. Just look at the veterans you see out there. Take a good look when you get the chance. You will still see it there. Whether 18 or 100, if they have worn the uniform, it is there, and they are connected.

Let me share a couple of examples:

Historians have said the Dwight Eisenhower was prouder of having been a soldier than he was of having been the President. While few ever reach the rank of general, the pride of a veteran in their military service is a bond that nearly all who have served share.

When Medal of Honor recipient Staff Sergeant Clinton Romesha received this nation's highest military medal, he said he felt conflicted. "The joy comes from recognition of us doing our jobs as soldiers in distant battlefields but is countered by the constant reminder of the loss of our battle buddies. My battle buddies. My soldiers. My friends," he said. His attitude is common among the living Medal of Honor recipients. They will never put receiving that award above, or ever forget, the sacrifice of their friends.

There is a lot of time spent thanking Veterans. Especially on this day. And it is appreciated, but honestly, it's unnecessary. Especially in this current era of an all-volunteer force, most of us spend our service living a dream. Flying the best jets this country has to the edge of their performance envelopes, and dominating the skies wherever we are tasked to go. It is a dream to be able to do that. Many of you have heard me say in our conversations, "You paid

me to do this too!" No, you don't need to thank me for it, I need to thank the taxpayers for letting me do it.

But you do need to thank someone though... our families. They don't get thanked for their service. They don't have a holiday dedicated to them. They don't get thanked for long absences, constantly moving all over the place, the constant fear for our safety, or not knowing when, or if, we'll come home. Those families have sacrificed, and they have done so in silence. (Well, maybe not so much in silence for some of them.) Yes, our families have sacrificed too. If you're going to take the time to thank a veteran today, please take the time to thank the family too. And since I'm holding the microphone, "To the families of all of our Veterans out there, thank you for being there for us. Our nation hasn't always been there for us, but you were. You deserve the applause.

For all the Veterans here today – thank you for your service and your sacrifice. I share the pride you feel in being able to count yourselves among the less than ten percent who have ever served, and among the less than one percent that are ever currently serving this great country – and the greatest military in the world.

And for those who thank me for my service. It has been my honor – you are worth it.

POINT OF PERSONAL PRIVILEGE

SEN. DEVER rose on a point of personal privilege.

REMARKS OF SENATOR DEVER

MR. PRESIDENT: Today is Veterans Day, formerly known as Armistice Day. In its early history, it commemorated the end of the "war to end all wars", on the eleventh hour, of the eleventh day, of the eleventh month in 1918. In 1954, the name was changed from Armistice Day to Veterans Day to honor all veterans, and importantly the values of our country for which they served.

Six years ago, I attended a commemoration of the seventieth anniversary of the end of World War II at the World War Memorial building here in Bismarck. Over 16 million Americans put on the uniform and the entire country got behind the war effort. The number that served represented 11% of the population at that time. The number serving now is less than 1% of the population. It makes a difference in our culture. 25 members of the ND State Legislature are veterans which is 17.7% of the membership. People who serve, serve.

At this event, a history was given of the War. It started with Pearl Harbor on the 7th of December 1941 and ended with V-E Day in May of 1945 and V-J Day in September of 1941. As I observed the 125 heroes of my Father's generation in an honored section, it occurred to me that, while we measure our wars in terms of time, when the young men and women put on the uniform, it is a lifetime commitment, their life is never the same.

Following 9/11, at public events, speakers would ask all veterans to stand and be recognized. The first few times, I felt that they didn't need to honor me. I came to realize that it is good for the country to recognize that freedom isn't free.

Four or five years ago, as I came out of church on a Sunday morning, a young man rode by on his bicycle and stopped to ask me, "Is this a friendly church?" I assured him that it was and invited him to go in and meet the Pastor. As we were walking back out, I said something to him, and he asked me to repeat myself. He said that he has an 80% hearing loss in his left ear from his time in the service. I asked him if was getting assistance from the V.A. He said, "No, and I never will because so many didn't come back." I said, "We need to talk." As he rode away, I noticed that he had a pint of whiskey in his back pocket. Much to my regret, I never saw him again.

We honor our dead in many ways. One of the ways we honor them is in the way we care for their comrades among the living. If you know anyone who is living with a service-connected disability and is not receiving assistance from the V.A., we need to talk. It would be good for the veteran. It would honor our fallen comrades, and it would be good for the country.

If time allows this morning, there will be a Veterans Day service at the Heritage Center, I encourage you all to attend.

REMARKS OF SENATOR MARCELLAIS

MR. PRESIDENT: Dear Veteran Brothers and Sisters: Across this great country and throughout the world, Americans will pause on Veterans Day to honor our brave fighting men and women who for more than 230 years have underwritten our freedom by their duty, honor and service. It's this devotion to duty that gives us all strength. Looking out on the world, we see our soldiers serving in over 100 countries throughout the world, and the legacy of our veterans continues to inspire our American soldiers today to answer the call to duty.

While we pay homage to all Veterans, I particularly want to thank our Vietnam Veterans and welcome them home. We served in a war that deeply divided our nation, but America is resilient! We are a country of temperance, compassion and reason; and with the passage of time we healed our wounds. To all our veterans, we have a simple yet heartfelt message, thank you.

Thank you for your unwavering service in peacetime and war, here in this nation and throughout the world. Happy Veterans Day!

SEN. WARDNER rose on a point of personal privilege.

REMARKS OF SENATOR WARDNER

MR. PRESIDENT: As we walk through these halls and debate the laws which are placed before us, we must remember that the ability to practice and participate in democracy is not given; it has been earned. To facilitate our rights as citizens was earned by these individuals who answered their nation's call. Today we stand on the shoulders of those who came before us, and our future is in the hands of those who come after us. STATEMENT OF PURPOSE OF AMENDMENT:

This amendment:

- Adjusts funding for career and technical education center projects to provide \$68.3 million from the federal Coronavirus Capital Projects Fund and \$20 million from the state fiscal recovery fund for total funding of \$88.3 million.
- Reduces funding from the federal Coronavirus Capital Projects Fund for broadband grants from \$60 million to \$45 million.
- Amends Section 7 relating to \$100 million of transportation funding for counties to provide \$24.7 million for county bridge projects grants and \$75.3 million to be distributed to counties for road and bridge projects based on Upper Great Plains Transportation Institute data with a limit of \$3 million per county.

"SECTION 18. APPROPRIATION - BANK OF NORTH DAKOTA. There is appropriated out of any moneys in the Bank of North Dakota operating fund in the state treasury, not otherwise appropriated, the sum of \$1,025,369, or so much of the sum as may be necessary, to the Bank of North Dakota for the purpose of salaries and wages funding, for the period beginning with the effective date of this Act, and ending June 30, 2023.

SECTION 19. APPROPRIATION - DEPARTMENT OF COMMERCE - ONE-TIME FUNDING - WORKFORCE COMMUNITY SERVICES PROGRAM. There is appropriated from federal funds, not otherwise appropriated, the sum of \$1,074,888, or so much of the sum as may be necessary, to the department of commerce for the purpose of the workforce community services program, for the period beginning with the effective date of this Act, and ending June 30, 2023. The funding provided under this section is considered a one-time funding item.

SECTION 20. APPROPRIATION - DEPARTMENT OF COMMERCE - ONE-TIME FUNDING - COMMUNITY DEVELOPMENT PLANNING GRANT PROGRAM. There is appropriated from federal funds, not otherwise appropriated, the sum of \$1,000,000, or so much of the sum as may be necessary, to the department of commerce for the purpose of a community development planning grant program, for the period beginning with the effective date of this Act, and ending June 30, 2023. The funding provided under this section is considered a one-time funding item.

SECTION 21. APPROPRIATION - DEPARTMENT OF COMMERCE - ONE-TIME FUNDING - WORKFORCE INNOVATION NETWORK GRANT PROGRAM. There is appropriated from special funds, not otherwise appropriated, the sum of \$100,000, or so much of the sum as may be necessary, to the department of commerce for the purpose of a workforce innovation network grant program, for the period beginning with the effective date of this Act, and ending June 30, 2023. The funding provided under this section is considered a one-time funding item.

SECTION 22. AMENDMENT. Section 9 of chapter 46 of the 2021 Session Laws is amended and reenacted as follows:

SECTION 9. BEYOND VISUAL LINE OF SIGHT UNMANNED AIRCRAFT SYSTEM PROGRAM - MATCHING FUND REQUIREMENT - ONE-TIME FUNDING. The grants line item in section 1 of this Act includes \$1,000,000 from the general fund for grants to an organization dedicated to expanding workforce opportunities, training, and education related to the beyond visual line of sight unmanned aircraft system industry, ~~which the~~ The department of commerce may provide funding under this section only to the extent the organization provides one dollar of matching funds from private or other public sources during the period beginning July 1, 2020, and ending June 30, 2023, for each one dollar provided by the department. This funding is considered a one-time funding item."

STATEMENT OF PURPOSE OF AMENDMENT:

This amendment:

- Appropriates \$1,025,369 from the Bank of North Dakota operating fund to the Bank for salaries and wages funding.
- Appropriates \$1,074,888 of federal funds to the Department of Commerce for the workforce community services program.
- Appropriates \$1 million of federal funds to the Department of Commerce for a community development planning grant program.
- Appropriates \$100,000 of special funds to the Department of Commerce for a workforce innovation network grant program.
- Amends Section 9 of Chapter 46 of the 2021 Session Laws to allow the Department of Commerce to accept matching funds raised prior to July 1, 2021, for the beyond visual line of sight unmanned aircraft system program provided for in Senate Bill No. 2018 (2021).

REPORT OF STANDING COMMITTEE

HB 1512: Joint Technical Corrections Committee (Sen. Lee, Co-Chairman) recommends **AMENDMENTS AS FOLLOWS** and when so amended, recommends **DO PASS** (16 YEAS, 0 NAYS, 0 ABSENT AND NOT VOTING). HB 1512 was placed on the Sixth order on the calendar.

Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to amend and reenact section 21-10-11 of the North Dakota Century Code, relating to the legacy and budget stabilization fund advisory board; to provide for the selection of a chairman; and to provide for an effective date.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 21-10-11 of the North Dakota Century Code is amended and reenacted as follows:

21-10-11. Legacy and budget stabilization fund advisory board.

1. The legacy and budget stabilization fund advisory board is created to develop recommendations for the investment of funds in the legacy fund and the budget stabilization fund to present to the state investment board.
2. The goal of investment for the legacy fund is principal preservation while maximizing total return and to provide a direct benefit to the state by investing a portion of the principal in the state. Preference must be given

- to qualified investment firms and financial institutions with a presence in the state for investment of the legacy fund.
3. The board shall determine the asset allocation for the investment of the principal of the legacy fund including:
 - a. A target allocation of ten percent to fixed income investments within the state, of which:
 - (1) Up to forty percent must be targeted for infrastructure loans to political subdivisions under section 6-09-49.1. The net return to the legacy fund under this paragraph must be fixed at a target rate of one and one-half percent;
 - (2) Up to sixty percent, with a minimum of four hundred million dollars, must be designated to the Bank of North Dakota's certificate of deposit match program with an interest rate fixed at the equivalent yield of United States treasury bonds having the same term, up to a maximum term of twenty years; and
 - (3) Any remaining amounts must be designated for other qualified fixed income investments within the state.
 - b. A target allocation of ten percent to equity investments in the state, of which at:
 - (1) At least three percent may be targeted for investment in one or more equity funds, venture capital funds, or alternative investment funds with a primary strategy of investing in emerging or expanding companies in the state. Equity investments under this subdivision paragraph must:
 - ~~(1)~~(a) Be managed by qualified investment firms, financial institutions, or equity funds which have a strategy to invest in qualified companies operating or seeking to operate in the state and which have a direct connection to the state; and
 - ~~(2)~~(b) Have a benchmark investment return equal to the five-year average net return for the legacy fund, excluding in-state investments.
 - (2) The legacy and budget stabilization fund advisory board shall develop guidelines for eligible investments under this paragraph. The advisory board shall receive and review proposals for eligible investments under this paragraph, and the advisory board shall consult with industry representatives, financial professionals, or other technical advisors to review the proposed investments. The advisory board shall submit recommendations for investments under this paragraph to the state investment board.
 4. The board consists of ~~two~~three members of the senate appointed by the senate majority leader, ~~two~~three members of the house of representatives appointed by the house majority leader, ~~the director of the office of management and budget or designee, the president of the Bank of North Dakota or designee, and the tax commissioner or designee, the insurance commissioner or designee, and the state treasurer or designee.~~ The board shall select a member from the senate or house of representatives to serve as chairman for no more than one consecutive year and must meet at the call of the chairman.
 5. The board shall report at least semiannually to the budget section.

6. Legislative members are entitled to receive compensation and expense reimbursement as provided under section 54-03-20 and reimbursement for mileage as provided by law for state officers. The legislative council shall pay the compensation and expense reimbursement for the legislative members.
7. The legislative council shall provide staff services to the legacy and budget stabilization fund advisory board.
8. The staff and consultants of the state retirement and investment office shall advise the board in developing asset allocation and investment policies.
9. The board ~~shall~~may develop a process to select a member of the board who is not a member of the state investment board to serve on the state investment board in a nonvoting capacity.

SECTION 2. LEGACY AND BUDGET STABILIZATION FUND ADVISORY BOARD - SELECTION OF CHAIRMAN. Pursuant to the requirement for the legacy and budget stabilization fund advisory board to select a chairman under subsection 4 of section 21-10-11, the advisory board shall select a new chairman during its first meeting after the effective date of this Act.

SECTION 3. EFFECTIVE DATE. This Act becomes effective on December 1, 2021."

SECTION 7. WATER PROJECTS STABILIZATION FUND - TRANSFERS.

1. The office of management and budget shall transfer the sum of \$1,000,000 from the resources trust fund to the water projects stabilization fund during the month of January 2022.
2. Notwithstanding subsections 1 and 2 of section 57-51.1-07, any oil extraction tax revenues deposited in the resources trust fund that exceed the amount included in the 2021 legislative forecast during the period beginning August 1, 2021, and ending February 28, 2023, must be

transferred at least quarterly by the office of management and budget from the resources trust fund to the water projects stabilization fund for the period beginning with the effective date of this Act, and ending June 30, 2023."
