- 2 section 39-06-14, and subsection 1 of section 39-06-14.2 of the North Dakota Century Code,
- 3 relating to nondriver photo identification cards and operator licenses for noncitizens.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Subsection 2 of section 39-06-03.1 of the North Dakota

- 6 Century Code is amended and reenacted as follows:
- 7 The director shall issue a nondriver color photo identification card to any resident who 2. 8 at the time of application is not a citizen of the United States and who fulfills the 9 requirements of this section. The identification card must be designed in a manner to 10 clearly make the card distinguishable from a similar card issued to a citizen of the 11 United States and resident of this state. Upon the issuance of an identification card, 12 the department of transportation shall provide a written notice that indicates the 13 naturalized individual shall contact the department of transportation to update the 14 individual's citizenship status. The individual shall update the citizenship status within 15 forty-five days following naturalization. The director shall replace the card may be-16 replaced with a card issued to a citizen of this country and resident of this state only 17 when proof of United States citizenship is provided by the individual and any 18 applicable replacement fee listed in section 39-06-49 is paid. For identification cards 19 issued under this subsection before August 1, 2023, the department of transportation 20 shall provide by mail to each cardholder a written notice that indicates within the 21 forty-five days following naturalization, the naturalized individual shall contact the 22 department of transportation to update the individual's citizenship status. 23 SECTION 2. AMENDMENT. Subsection 5 of section 39-06-14 of the North Dakota Century 24 Code is amended and reenacted as follows:

1	5.	The director shall issue an operator's license to any resident who at the time of
2		application is not a citizen of the United States and who fulfills the requirements of this
3		section. The license must be designed in a manner to distinguish the license clearly
4		from a similar license issued to a citizen of the United States and resident of this state.
5		Upon the issuance of a license, the department of transportation shall provide a
6		written notice that indicates the naturalized individual shall contact the department of
7		transportation to update the individual's citizenship status. The individual shall update
8		the citizenship status within forty-five days following naturalization. The director shall
9		replace the license issued under this subsection may be replaced with a card issued to
10		a citizen of this country and resident of this state only when proof of United States
11		citizenship is provided by the individual and the replacement fee listed in section
12		39-06-49 is paid. For licenses issued under this subsection before August 1, 2023, the
13		department of transportation shall provide by mail to each licenseholder a written
14		notice that indicates within the forty-five days following naturalization, the naturalized
15		individual shall contact the department of transportation to update the individual's
16		citizenship status.
17	SEC	CTION 3. AMENDMENT. Subsection 1 of section 39-06-14.2 of the North Dakota
18	Century	Code is amended and reenacted as follows:
19	1.	The director shall provide central identity management for all state agencies for
20		citizens who possess a nondriver photo identification card or driver's license
21		utilizingusing driver record data. Upon an individual's change in citizenship status
22		under section 39-06-03.1 or 39-06-14, the director shall report to the secretary of state
23		the individual's updated information as required under section 16.1-02-09.
