1 A BILL for an Act to provide an appropriation for defraying the expenses of the commissioner of

2 university and school lands; and to provide for distributions from permanent funds.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds 5 as may be necessary, are appropriated out of any moneys from special funds derived from the 6 state lands maintenance fund in the state treasury, to the commissioner of university and school 7 lands for the purpose of defraying the expenses of the commissioner of university and school 8 lands, for the biennium beginning July 1, 2023, and ending June 30, 2025, as follows:

The commissioner of university and school lands shall report to the appropriations committees of the sixty-ninth legislative assembly on the use of this one-time funding for the biennium beginning July 1, 2023, and ending June 30, 2025.

16 **SECTION 3. DISTRIBUTIONS TO STATE INSTITUTIONS.** Pursuant to article IX of the 17 Constitution of North Dakota, the board of university and school lands shall distribute during the 18 biennium beginning July 1, 2023, and ending June 30, 2025, the following amounts, from the 19 permanent funds managed for the benefit of the following entities:
