1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;

2 and to amend and reenact section 54-11-13 of the North Dakota Century Code, relating to the

3 salary of the state treasurer.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury, not otherwise appropriated, to the state treasurer for the purpose of defraying the
expenses of the state treasurer, for the biennium beginning July 1, 2023, and ending June 30,
2025, as follows:

21	54-11-13. Salary of state treasurer.				
22	The annual salary of the state treasurer is one hundred twelvenineteen thousand two-				
23	hundred forty-one <u>sixty-five</u> dollars through June 30, 2022 2024, and one hundred				
24	fourteen <u>twenty-three</u> thousand four <u>eight</u> hundred eighty-sixtwenty-eight dollars thereafter.
