## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, to the ethics commission for the purpose of defraying the expenses of the ethics commission, for the biennium beginning July 1, 2023, and ending June 30, 2025, as follows:

The ethics commission shall report to the appropriations committees 5 of the sixty-ninth legislative assembly on the use of this one-time funding for the biennium 6 beginning July 1, 2023, and ending June 30, 2025. 7 SECTION 3. LEGISLATIVE MANAGEMENT STUDY - FEE STRUCTURE. During the 8 2023-24 interim, the legislative management shall consider studying the feasibility and 9 desirability of establishing a rate structure to offset the operating expenses of the ethics 10 commission. The study must include a comparison of the funding method for ethics 11 commissions used by other states within the region. The legislative management shall report its 12 findings and recommendations, together with any legislation required to implement the 13 recommendations, to the sixty-ninth legislative assembly. 14 SECTION 4. REPORT - ETHICS COMMISSION ACTIVITIES. During the 2023-24 interim. 15 the ethics commission shall provide reports to the legislative management regarding the 16 activities and operations of the commission. The reports must include information regarding the 17 number of complaints received by the commission, education and outreach efforts, and the 18 status of the commission's budget. 19 **SECTION 5. EMERGENCY.** The sum of \$97,000 for attorney fees and office relocation 20 costs included in the ethics commission line item in section 1 of this Act is declared to be an 21 emergency measure.
