- 1 A BILL for an Act to amend and reenact section 12.1-17-01 of the North Dakota Century Code,
- 2 relating to assault on a health care facility employee; and to provide a penalty.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 12.1-17-01 of the North Dakota Century Code is

5 amended and reenacted as follows:

- 6 **12.1-17-01. Simple assault.**
- 7 1. A person is guilty of an offense if that person:
- 8 a. Willfully causes bodily injury to another human being; or
- 9 b. Negligently causes bodily injury to another human being by means of a firearm,
 10 destructive device, or other weapon, the use of which against a human being is
 11 likely to cause death or serious bodily injury.

- a. A class C felony when<u>if</u> the victim is a<u>:</u>
- 14 (1) <u>A peace officer or correctional institution employee acting in an official</u>
 15 capacity, which the actor knows to be a fact; an
- 16 (2) <u>An employee of the state hospital acting in the course and scope of</u>
 17 employment, which the actor knows to be a fact, and the actor is an
 18 individual committed to or detained at the state hospital pursuant to chapter
 19 25-03.3; a person
 - (3) <u>An individual</u> engaged in a judicial proceeding; or a
- <u>(4)</u> <u>A member of a municipal or volunteer fire department or emergency medical
 services personnel unit or emergency department worker in the
 performance of the member's duties; or

1	(5)	An individual employed or contracted by a healthhospital, clinic, or long-term
2		care facility, which the actor knows to be a fact, and the assault occurs on
3		the healthhospital, clinic, or long-term care facility property. For purposes of
4		this paragraph, "health care facility" means an office or institution providing
5		health care services or treatment of diseases, whether physical, mental, or
6		emotional, or other medical, physiological, or psychological conditions,
7		including a hospital, clinic, ambulatory surgery center, outpatient care
8		facility, weight control clinic, nursing home, basic care or assisted living
9		facility, laboratory, or office of any medical professional licensed or
10		registered under title 43 or any individual included within a specialty or
11		subspecialty of those fields. The term includes a waiting room, hallway,
12		private room, semiprivate room, ward, and any mobile or temporary facility.
