- 1 A BILL for an Act to create and enact chapter 43-47.1 of the North Dakota Century Code,
- 2 relating to adoption of the counseling compact.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1.** Chapter 43-47.1 of the North Dakota Century Code is created and enacted as follows:
- 6 <u>43-47.1-01. Counseling compact.</u>

7 ARTICLE I - PURPOSE

- The purpose of this compact is to facilitate interstate practice of licensed professional
 counselors with the goal of improving public access to professional counseling
- 10 services.
- 11 <u>2. The practice of professional counseling occurs in the state where the client is located</u>
- 12 <u>at the time of the counseling services. The compact preserves the regulatory authority</u>
- of states to protect public health and safety through the current system of state
- 14 <u>licensure.</u>
- 15 <u>3. This compact is designed to:</u>
- a. <u>Increase public access to professional counseling services by providing for the</u>
 mutual recognition of other member state licenses;
- b. Enhance the states' ability to protect the public's health and safety;
- 19 <u>c. Encourage the cooperation of member states in regulating multistate practice for licensed professional counselors;</u>
- 21 <u>d. Support spouses of relocating active duty military personnel;</u>
- e. Enhance the exchange of licensure, investigative, and disciplinary information
 among member states;

1 Allow for the use of telehealth technology to facilitate increased access to 2 professional counseling services; 3 g. Support the uniformity of professional counseling licensure requirements 4 throughout the states to promote public safety and public health benefits; 5 <u>h.</u> <u>Invest all member states with the authority to hold a licensed professional</u> 6 counselor accountable for meeting all state practice laws in the state in which the 7 client is located at the time care is rendered through the mutual recognition of 8 member state licenses; 9 Eliminate the necessity for licenses in multiple states; and 10 Ĺ. Provide opportunities for interstate practice by licensed professional counselors 11 who meet uniform licensure requirements. 12 **ARTICLE II - DEFINITIONS** 13 As used in this chapter, and except as otherwise provided, the following definitions apply: 14 1. "Active duty military" means full-time duty status in the active uniformed service of the 15 United States of America, including members of the national guard and reserve on 16 active duty orders pursuant to 10 U.S.C. chapters 1209 and 1211. 17 <u>2.</u> "Adverse action" means any administrative, civil, equitable, or criminal action 18 permitted by a state's laws which is imposed by a licensing board or other authority 19 against a licensed professional counselor, including actions against an individual's 20 license or privilege to practice, such as revocation, suspension, probation, monitoring 21 of the licensee, limitation on the licensee's practice, or any other encumbrance on 22 licensure affecting a licensed professional counselor's authorization to practice, 23 including issuance of a cease and desist action. 24 <u>3.</u> "Alternative program" means a nondisciplinary monitoring or practice remediation 25 process approved by a professional counseling licensing board to address impaired 26 practitioners. 27 <u>4.</u> "Continuing competence and education" means a requirement, as a condition of 28 license renewal, to provide evidence of participation in, and completion of, educational 29 and professional activities relevant to practice or area of work. 30 "Counseling compact commission" or "commission" means the national administrative <u>5.</u> 31 body which membership consists of all states that have enacted the compact.

1 "Current significant investigative information" means: 2 Investigative information that a licensing board, after a preliminary inquiry that <u>a.</u> 3 includes notification and an opportunity for the licensed professional counselor to 4 respond, if required by state law, has reason to believe is not groundless and, if 5 proved true, would indicate more than a minor infraction; or 6 <u>b.</u> Investigative information that indicates the licensed professional counselor 7 represents an immediate threat to public health and safety regardless of whether 8 the licensed professional counselor has been notified and had an opportunity to 9 respond. 10 "Data system" means a repository of information about licensees, including continuing 7. 11 education, examination, licensure, investigative, privilege to practice, and adverse 12 action information. 13 "Encumbered license" means a license in which an adverse action restricts the 8. 14 practice of licensed professional counseling by the licensee and the adverse action 15 has been reported to the national practitioner data bank. 16 "Encumbrance" means a revocation or suspension of, or any limitation on, the full and 9. 17 unrestricted practice of licensed professional counseling by a licensing board. 18 <u>10.</u> "Executive committee" means a group of directors elected or appointed to act on 19 behalf of, and within the powers granted to them by, the commission. 20 <u>11.</u> "Home state" means the member state that is the licensee's primary state of 21 residence. 22 12. "Impaired practitioner" means an individual who has a condition that may impair the 23 individual's ability to practice as a licensed professional counselor without some type 24 of intervention and may include alcohol and drug dependence, mental health 25 impairment, and neurological or physical impairments. 26 <u>13.</u> "Investigative information" means information, records, and documents received or 27 generated by a professional counseling licensing board pursuant to an investigation. 28 "Jurisprudence requirement", if required by a member state, means the assessment of 14. 29 an individual's knowledge of the laws and rules governing the practice of professional 30 counseling in a state.

In accordance with due process and that state's laws, 24 a remote state may remove a licensee's privilege to practice in the remote state for a 25 specific period of time, impose fines, and take any other necessary actions to protect 26 the health and safety of its citizens. The licensee may be ineligible for a privilege to 27 practice in any member state until the specific time for removal has passed and all 28 fines are paid. 29 5. If a home state license is encumbered, the licensee shall lose the privilege to practice 30 in any remote state until the following occur: 31 The home state license is no longer encumbered; and

1 under a privilege to practice as provided in the compact and rules promulgated by the 2 commission. 3 <u>2.</u> A licensee providing professional counseling services in a remote state under the 4 privilege to practice shall adhere to the laws and regulations of the remote state. 5 **ARTICLE VIII - ADVERSE ACTIONS** 6 <u>1.</u> In addition to the other powers conferred by state law, a remote state must have the 7 authority, in accordance with existing state due process law, to: 8 Take adverse action against a licensed professional counselor's privilege to 9 practice within that member state; and 10 Issue subpoenas for both hearings and investigations that require the attendance b. 11 and testimony of witnesses as well as the production of evidence. Subpoenas 12 issued by a licensing board in a member state for the attendance and testimony 13 of witnesses or the production of evidence from another member state must be 14 enforced in the latter state by any court of competent jurisdiction, according to the 15 practice and procedure of that court applicable to subpoenas issued in 16 proceedings pending before the court. The issuing authority shall pay any witness 17 fees, travel expenses, mileage, and other fees required by the service statutes of 18 the state in which the witnesses or evidence are located. 19 <u>2.</u> Only the home state has the power to take adverse action against a licensed 20 professional counselor's license issued by the home state. 21 <u>3.</u> For purposes of taking adverse action, the home state shall give the same priority and 22 effect to reported conduct received from a member state as the home state would if 23 the conduct had occurred within the home state. In so doing, the home state shall 24 apply its state laws to determine appropriate action. 25 <u>4.</u> The home state shall complete any pending investigations of a licensed professional 26 counselor who changes primary state of residence during the course of the 27 investigations. The home state also has the authority to take appropriate action and 28 promptly shall report the conclusions of the investigations to the administrator of the 29 data system. The administrator of the coordinated licensure information system 30 promptly shall notify the new home state of any adverse actions.

1 A member state, if otherwise permitted by state law, may recover from the affected 2 licensed professional counselor the costs of investigations and dispositions of cases 3 resulting from any adverse action taken against that licensed professional counselor. 4 A member state may take adverse action based on the factual findings of the remote 6. 5 state, provided that the member state follows its procedures for taking the adverse 6 action. 7 Joint investigations: 7. 8 In addition to the authority granted to a member state by its respective 9 professional counseling practice act or other applicable state law, any member 10 state may participate with other member states in joint investigations of 11 licensees. 12 <u>b.</u> Member states shall share any investigative, litigation, or compliance materials in 13 furtherance of any joint or individual investigation initiated under the compact. 14 <u>8.</u> If adverse action is taken by the home state against the license of a licensed 15 professional counselor, the licensed professional counselor's privilege to practice in all 16 other member states must be deactivated until all encumbrances have been removed 17 from the state license. All home state disciplinary orders that impose adverse action 18 against the license of a licensed professional counselor must include a statement that 19 the licensed professional counselor's privilege to practice is deactivated in all member 20 states during the pendency of the order. 21 <u>9.</u> If a member state takes adverse action, the member state promptly shall notify the 22 administrator of the data system. The administrator of the data system promptly shall 23 notify the home state of any adverse actions by remote states. 24 <u>10.</u> This compact does not override a member state's decision that participation in an 25 alternative program may be used in lieu of adverse action. 26 ARTICLE IX - ESTABLISHMENT OF COUNSELING COMPACT COMMISSION 27 1. The compact member states hereby create and establish a joint public agency known 28 as the counseling compact commission. 29 The commission is an instrumentality of the compact states. a. 30 Venue is proper and judicial proceedings by or against the commission must be <u>b.</u> 31 brought solely and exclusively in a court of competent jurisdiction where the
