8			(1)	A quorum of the members of the governing body of a public entity regarding

10			(2)	Less than a quorum of the members of the governing body of a public entity
11				regarding public business, if the members attending one or more of the
12				smaller gatherings collectively constitute a quorum and if the members hold
13				the gathering for the purpose of avoiding the requirements of section
14				44-04-19.
15		b.	"Me	eting" does not include:
16			(1)	A chance or social gathering at which public business is not considered;
17			(2)	Emergency operations during a disaster or emergency declared under
18				section 37-17.1-10 or an equivalent ordinance if a quorum of the members
19				of the governing body are present but are not discussing public business as
20				the full governing body or as a task force or working group;
21			(3)	The attendance of members of a governing body at meetings of any
22				national, regional, or state association to which the public entity, the
23				governing body, or individual members belong;
