HB 1168 creates an income tax credit for the purchases of manufacturing machinery and equipment to automate a manufacturing process.

Section 1 of HB 1168 sets forth the provisions of an income tax credit equal to twenty percent of the cost of the manufacturing machinery and equipment purchased in the taxable year. To qualify for the tax credit, the equipment must lead to improved job quality or increased productivity.

The provisions of the bill limit the combined allowable tax credits to a maximum of \$2.5 million per calendar year. The fiscal note assumes this limit is reached each year of the 2023-2025 biennium and will cause a revenue reduction of \$5 million from the state general fund.
