HB 1406 requires the department to study and maintain records on the effects of any SARS - CoV - 2 vaccine. If it promotes, markets, or advertises the vaccine, it shall cover the costs of treatment and diagnostics for individuals who suffer any "physical injury."

4 - Fiscal Impact Sections Detail

Section 1 requires a study and the maintenance of records on the effects of any vaccine intended to develop an immune system response to SARS - CoV - 2 and any mutation or viral fragments of SARS - CoV - 2. The Department would anticipate contracting with a provider or University to conduct the study. NDIT would need to build or host a system to maintain the records. Education materials would need to be created and distributed to health

care professionals and the public. The Department would require one FTE to oversee the project. This section also designates that if the Department promotes, markets, or advertises any COVID vaccine, the Department would be required to cover the costs of treatment and diagnostics for any individual who suffers any "physical injury" due to receiving the vaccine. A panel of three physicians to review claims of physical injury would be needed. The Department anticipates the need for legal fees due to potential lawsuits. And funds may be needed to pay for potential claims for injuries.

Section 1 requires a study and the maintenance of records. The Department anticipates contracting with a provider or University to conduct the study on the effects of the vaccine at a cost of \$3,000,000 in the 23-25 biennium and \$3,150,000 in the 25-27 biennium. The cost for NDIT to build a system to maintain the records is estimated at \$2,510,000 in the 23-25 biennium and \$226,600 to maintain the system in the 25-27 biennium. Education materials would need to be created and distributed to health care professionals and the public at a cost of \$20,000 in each of the 23-25 and 25-27 bienniums. The Department would require one FTE to oversee the project at a cost of \$225,124 for the 23-25 and 25-27 bienniums.

This section also designates if the Department promotes, markets, or advertises any COVID vaccine, the Department would be required to cover the costs of treatment and diagnostics for any individual who suffers any "physical injury" due to receiving the vaccine. The need for a panel of 3 physicians to review claims of injury is anticipated to cost \$750,000 in each of the 23-25 and 25-27 bienniums. The Department anticipates the need for legal fees due to potential law suites at \$500,000 in each of the 23-25 and 25-27 bienniums. The average reimbursement through the National Vaccine Injury Compensation program (VICP) is \$357,000 per claim. Physical injury is not defined in HB 1406 but, limiting it to 20 claims per biennium would cost \$7,140,000 in each of the 23-25 and 25-27 bienniums.
