**3 - Bill and Fiscal Impact Summary**

HB 1406 creates a liability for the department if it promotes, markets, or advertises any mRNA or COVID-19 vaccine or future variant as safe. The department shall cover the costs of treatment and diagnostics for individuals who suffer any "physical injury."

Section 1 designates if the department promotes, markets, or advertises any mRNA or COVID-19 vaccine, the department would be required to cover the costs of treatment and diagnostics for any individual who suffers any “physical injury” due to receiving the vaccine. The department would require one FTE to oversee potential claims. A panel of three physicians to review claims of physical injury would be needed. The department anticipates the need for legal fees due to potential lawsuits. Funds may be needed to pay for potential claims for injuries.

Section 1 designates if the department promotes, markets, or advertises any mRNA or COVID-19 vaccine, the department would be required to cover the costs of treatment and diagnostics for any individual who suffers any “physical injury” due to receiving the vaccine. The department would require one FTE to oversee potential claims at a cost of \$225,124 in each of the 23-25 and 25-27 bienniums. The need for a panel of 3 physicians to review claims of injury is anticipated to cost \$750,000 in each of the 23-25 and 25-27 bienniums. The department anticipates the need for legal fees due to potential law suites at \$500,000 in each of the 23-25 and 25-27 bienniums. The average reimbursement through the National Vaccine Injury Compensation program (VICP) is \$357,000 per claim. Physical injury is not defined in HB 1406, however, if there are 20 potential paid claims per biennium the cost is estimated at \$7,140,000 in each of the 23-25 and 25-27 bienniums.
