HB 1402 creates a sales tax exemption for used clothing sold by a thrift store of a nonprofit corporation and allow delivery charges to be deducted from the total amount subject to sales tax.

Section 2 of HB 1402 removes delivery charges from the total amount of consideration that is subject to sales tax. This would allow delivery charges to be exempt from sales tax.

Section 3 of HB 1402 would create a sales tax exemption for used clothing sold by a thrift store of a nonprofit corporation.

Section 2 of HB 1402 would allow delivery charges to be exempt from sales tax. If enacted, this will create a decrease in the state general fund and the state aid fund. The information reported to the Office of State Tax Commissioner does not include the details necessary to separate delivery charges from the total taxable sales and purchases amounts. Due to this fact, the Office of State Tax Commissioner is unable to provide a reliable estimate for the revenue reduction amount.

Section 3 of HB 1402 creates a sales tax exemption for used clothing sold by a thrift store of a nonprofit corporation. If enacted, this will create a decrease in the state general fund and the state aid fund. The total taxable sales and purchases from a thrift store of a nonprofit corporation are \$1.2 million per biennium. Under the assumption that approximately 25% to 55% of all sales sold by a thrift store of a nonprofit corporation are for used clothing, then the midpoint of this amount would be an estimated revenue reduction of \$480,000.
