Engrossed SB 2334 removes the sunset on a sales tax exemption for fertilizer plants, allocates sales tax revenue, and provides a legislative management report.

Section 1 of engrossed SB 2334 will remove the sunset for a sales tax exemption for the sales used to construct a fertilizer or chemical processing facility in this state.

Sections 2 and 3 have no state fiscal impact.

If enacted, Section 1 of engrossed SB 2334 will create a reduction in revenue to both the general fund and the state aid fund on any eligible exemption claims. To date, the Office of State Tax Commissioner has not received any requests for a sales tax exemption for sales used to construct a fertilizer or chemical processing facility in this state. It is unknown whether future claims will be made for this exemption. Due to this fact, the Office of State Tax Commissioner is unable to provide a reliable estimate for the revenue reduction amount.
