# CORRECTION AND REVISION OF THE JOURNAL

**MADAM PRESIDENT:** Your **Committee on Correction and Revision of the Journal (Sen. Beard, Chairman)** has carefully examined the Journal of the Fifty-fourth Day and recommends that it be corrected as follows and when so corrected, recommends that it be approved:

Page 1199, after line 15, insert "In lieu of the amendments as printed on pages 1174-1178 of the Senate Journal, Engrossed House Bill No. 1028 is amended as follows:"

Page 1212, lines 33 and 34, replace "**DO NOT PASS** (4 YEAS, 2 NAYS, 0 ABSENT AND NOT VOTING)" with "**BE PLACED ON THE CALENDAR WITHOUT RECOMMENDATION** (6 YEAS, 0 NAYS, 0 ABSENT AND NOT VOTING)"

Page 1213, after line 10, insert: "In lieu of the amendments as printed on pages 1178 and 1179 of the Senate Journal, Engrossed House Bill No. 1095 is amended as follows:"

**SEN. BEARD MOVED** that the report be adopted, which motion prevailed.

## VETO MEASURE

Pursuant to Article V, Section 9 of the North Dakota Constitution, I have vetoed Senate Bill 2231 and return it to the Senate.

Section 1 of Senate Bill 2231 codifies First Amendment protections against compelled speech, setting state policy addressing pronoun use by state employees. However, vetoing Section 1 changes nothing, because under existing free speech protections, a state employee already cannot be required to use preferred pronouns but may still voluntarily do so. I would have no objections to signing this bill if it contained only Section 1.

Section 2 infringes on local control by unnecessarily injecting the state into rare instances most appropriately handled at the parent, teacher and school district level. This section removes discretion from school boards, schools and teachers in determining how to accommodate the needs of all students in public schools. Further, the First Amendment already prohibits compelled speech and protects teachers from speaking contrary to their beliefs, and courts across the country have upheld these rights.

Ambiguity throughout this bill would invite lawsuits and put teachers in the precarious position of trying to determine how to refer to students without violating law. The teaching profession is challenging enough without the heavy hand of state government forcing teachers to take on the role of pronoun police. Parents, teachers and administrators using compassion, empathy and common sense can address individual and infrequent situations that may arise.

At the end of the day, children are the future of our state, and we have a duty to protect all of them. North Dakota will continue to stand for free speech, local control and freedom from discrimination.

For the reasons stated above, Senate Bill 2231 is vetoed.

REMARKS OF CANADA'S COUSUL GENERAL ARIEL DELOUYA MARCH 30, 2023

Madam President and Distinguished Senators:

Thank you very much for inviting me to address this chamber and those whom the people of

the great State of North Dakota elected to defend their interests. It is truly an honor.

Your gracious invitation is a testament to the warmth and importance of the relationship between Canada and North Dakota, and the broader relationship between Canada and the United States, which is unparalleled in modern international relations.

As a Canadian, and as a guest of your great state and its Senate, it is important to pause and recognize the original stewards of these lands, the indigenous inhabitants of north America. Canada is committed to the ongoing process of reconciliation with indigenous peoples.

In that spirit, I want to honor the Dakota and Anishinaabe people – and in particular, the five federally recognized tribes located within North Dakota: the Sisseton Wahpeton Oyate; Spirit Lake Nation; Standing Rock Sioux tribe; Mandan, Hidatsa, and Arikara Nation; and Turtle Mountain Band of Chippewa. We thank them for continuing to steward and protect the lands and waters of our common home.

**Distinguished Senators:** 

I have the honor and privilege of serving as consul general of Canada in Minneapolis, and as my government's top diplomatic representative in the US upper Midwest States of North Dakota, Minnesota, Iowa, Nebraska, and South Dakota.

After more than four years in this deeply fulfilling and satisfying assignment, my time representing Canada in this part of the world – a part of the world that is both literally and figuratively close to Canada and Canadians, is coming to an end.

In my foreign service career of nearly 37 years, I have had the enormous good fortune of serving my country all across the globe. from Turkey to Washington, DC, and prior to this posting, as ambassador to Tunisia, I've represented Canada, conducting my country's diplomatic relations and working hard: to connect Canada and Canadians with elected officials and members of the public; to promote Canadian expertise and businesses; to serve Canadians in need of assistance; and perhaps most importantly, to project Canadian values.

I've worked in areas of the world where these values we hold so dear: peace; democracy; freedom; the rule of law; human rights; equal opportunity; security; sustainability; and economic growth and prosperity – are either ignored, or actively suppressed by authorities.

We share these values with the United States and her people, and have defended and promoted them throughout the world, both in times of war and in peace, for more than a century.

So, I come before you today with clear-eyed appreciation and gratitude for all that we in North America have built through hard work, ingenuity, and perseverance, and enjoy today.

Let none of it be lost on us. We are fortunate to have each other as neighbors. To quote President Ronald Reagan, we enjoy the "deep, unbending bonds of trust between old and devoted friends. And it takes understanding."

So, if you'll indulge a request by a soon-to-be-retired diplomat, I'd ask you, today, to be purposeful in supporting this remarkable friendship, built on an endless number of personal connections, including among lawmakers at every level; federal, state/provincial/territorial, and local.

No two nations depend more on each other for their mutual prosperity and security than the United States and Canada. Our nations are bound by our geography, history, values, economy, environment, and our resolve to improve the lives of our citizens. As President Kennedy so famously declared in 1961 when he addressed Canada's parliament in Ottawa: "Geography has made us neighbors. History has made us friends. Economics has made us partners. And necessity has made us allies. Those whom nature hath so joined together, let no man put asunder."

This partnership has resulted in one of the richest and freest regions in the world.

Still, we must be realistic about the world today: the interconnected global economy that we

helped build is at risk. It is time for us to strengthen our connection with each other as we consider this new global paradigm, and address the gathering risks, and the growing threat to our values and interests that we face from geostrategic rivals.

The building blocks for a strengthened U.S.-Canada relationship are already in place. We have our longstanding foreign policy and security cooperation, free and fair trade under the United States-Mexico-Canada Trade Agreement (USMCA), our commitment to protect our environment, and the stability that comes from the North American integrated energy market, something North Dakota understands better than most. Most importantly, however, there are the deep and centuries-old people-to-people connections that exist between our countries.

But in the face of the increased foreign interference from hostile state actors that I noted earlier, we must go further in our cooperation. This must include friend-shoring within the North American market, including for the critical minerals so essential to our long-term prosperity and security, enhanced preparedness to meet and counter threats to our homelands, and a commitment to values-based partnerships with our allies.

We will succeed or fail together in this new world. Now is not the time for retrenchment or protectionist policies that will harm North American jobs or limit our ability to support each other with goods and critical materials in the face of supply chain blockages.

Disagreements are inevitable in a partnership as large and complex as ours. but Canada is invested in the success of the United States, and we'll always be ready to work towards solutions, as we have in the past.

And I know you are of the same mind. I've been witness to your willingness to strengthen the North-Dakota-Canada relationship first-hand these last four years.

I've seen it from those of you who are North Dakota's delegates to the International Legislators Forum, a partnership between North Dakota, Manitoba, Minnesota, and South Dakota.

I've seen it from those of you who are part of the Midwest Canada Relations Committee of the Council of State Governments Midwestern Legislative Conference.

I've seen it from Governor Burgum, and to cite one powerful example in his readiness to help your neighbors in Manitoba and Saskatchewan during the pandemic, and other members of his administration. North Dakota is not lacking in leaders who are willing to reach out. To meet your Canadian counterparts. To listen and learn. To find common ground.

That's true leadership. That's how you make a relationship work. It's how you make a neighborhood thrive. It's the North Dakota way.

And I can tell you – Canada appreciates North Dakota.

The Canada-North Dakota relationship is deep and mutually beneficial.

Canada is, far and away, and without a doubt, North Dakota's number one customer. And it's not even close. In fact, North Dakota sells more goods to Canada than to all other countries in the world – combined!

You're welcome.

Our geography as neighbors and our history as partners means that Canada and North Dakota are connected in numerous ways.

We trade in agriculture. We trade in energy.

And we build and make things together through integrated supply chains.

We protect our shared environment together – water, air, and land - and are taking action to mitigate the risks posed by climate change. And we share a long, friendly border – indeed, the longest in the world.

As we look around the globe and see example after example of neighboring countries in

conflict, or outright war - this is truly something to celebrate.

The world recently marked a sober milestone: the one-year anniversary since Russia invaded Ukraine. Canada and the United States, as allies, stand together in responding to this crisis, as we have as in so many others across the globe and throughout history.

Our many military and security partnerships unite us in defense of North America, promote peace and security internationally, secure our homelands, and defend our democratic values.

Canadian and American troops fought together in World War I, World War II, in the Korean war, and in Afghanistan.

We thank our brave men and women who work together, every day, in all corners of the world, to keep us safe.

Because it's true. Freedom is not free. Democracy is not a given. President Reagan said it best: freedom is never more than one generation away from extinction.

We are so fortunate here. Sometimes we have a tendency to take our good fortune for granted. To take our neighbor for granted.

Over my many years living and working in the US, I have come to appreciate the Canadian-United States relationship for what it is: the single greatest friendship and partnership in the world.

Thank you for inviting me to be with you today. on behalf of the government of Canada, I extend my warmest wishes for a successful conclusion of this legislative session. and I thank you for being such great friends and partners for Canada.
