## OIL AND GAS TAX REVENUES MONTHLY UPDATE

This memorandum provides an update on oil production and prices, oil and gas tax revenue collections, and oil and gas tax revenue allocations for July 2022 and for the biennium to date. **The forecasted amounts reflect the 2021 legislative revenue forecast**, prepared at the close of the 2021 regular legislative session. The oil revenue forecast was not changed during the November 2021 special legislative session.

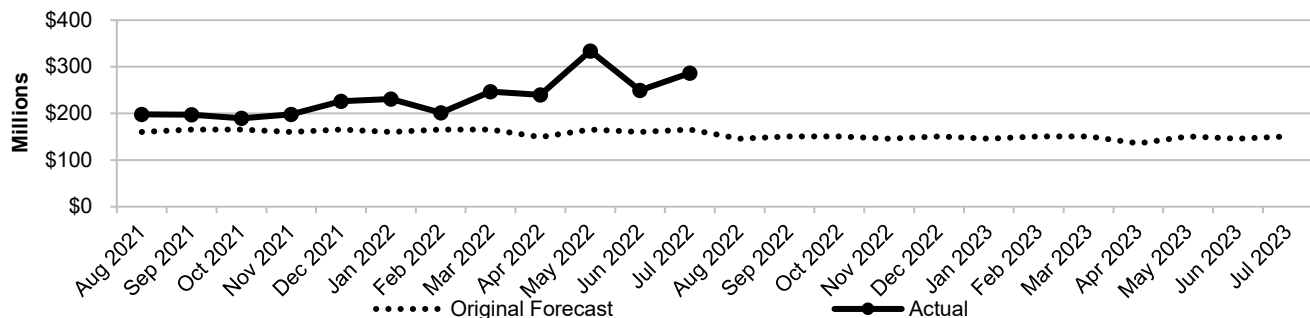
### OIL PRODUCTION AND PRICES

The actual oil prices reflect the average of Flint Hills Resources posted prices and West Texas Intermediate posted prices.
