<u>Representative Klein</u>, Chairman of the GVA Committee opened the hearing on January 21, 1999. <u>Summary of the Bill</u>: Relating to the organization of firefighters relief associations by fire departments.

Representative Klemin, So we don't know the answer to that?

Drovdal, There is no challenge.

<u>Representative Metcalf</u>, Do they have adequate funds to provide equipment and training? Still provide this also?

Drovdal, Yes.

Representative Haas, Does the firefighters match the amount put into it?

<u>Drovdal</u>, That's up to the individual person. The plan we went into contributes a 100 dollars per year.

## TESTIMONY for HB 1201

## Prepared by Representative David Drovdal District 39

Mr. Chairman Klein and members of the Government and Veterans Affairs Committee. For the record my name is David Drovdal, Representative from the 39th District. The bill before you was at the request of the North Dakota Fireman Association and the Watford City Volunteer Fire Department. It comes because of a ruling by the Attorney General in 1997 and has two objectives. To explain why they are needed let me first give you some history. I would first like to declare that I do have a conflict of interest in the outcome of this bill.

North Dakota has three different types of fire departments serving the residents of this state. Those departments that have all full time firefighters. Those departments that may have several full time members and the balance as volunteers and departments that are staffed by all volunteers. The latter is by far the largest group and they can be split between departments that require vigorous training and those that just ask volunteers to show up at fires.

Over the last number of years it has become harder and harder to find people that are willing to volunteer their time for community service. This is caused partly because of the two family income, more single parents, the time required for the training, risk of the hazards and fewer young people in rural areas. This has been especially true in departments that are requiring mandatory meetings, training in hazardous material, state fire school attendance, etc. Many of these departments also operate rescue operations that require even more training. Many of these departments were finding volunteer burnout after members had been in about 10 years. These members represented training, experience, leadership and an investment by the department. These departments, with the consent and knowledge of the governing boards, decided that one of the most important assets they had was their volunteers. Yes, equipment and training are important, but the knowledge and experience are needed to use that equipment. These departments have in the past, and some will in the future, chose to put some of their money aside in a retention plan that may include a retirement account for volunteers that qualified for it. Those qualifications included longer time as a volunteer. For instance, in the department that I spent 23 years, this retention plan had a very positive effect. In the first 70 years they had only about three members that

had served 20 years, after they passed a retention plan, they doubled that in just 6 years and saw an increase in average years of service. The decision to start a retention plan and the amount to invest it was totally up to the local authorities and subject to their needs and priorities. In other words if equipment or expenses became a problem, they could reduce contributions to the plan at their discretion.


The reason I am telling you this is that some of the money that the local fire departments operate with, come from premium rebates that insurance companies send to the State. This has been an ongoing rebate and this bill doesn't change any of that. The 1997 ruling stated that only departments with full time paid firefighters could use this money to fund retirement accounts. The first thing this bill does si to allow departments to use all or part of this rebate to fund these accounts, and volunteers are eligible to be vested members after they meet the qualifications established by the departments and the State.

The second change is more of a clarification. The state requires a fund member to be invested for 10 years , but it's hard to tell if that means 10 years as a volunteer or 10 years in the Retirement Plan. The bill would allow credit for time in the department to count toward the volunteer's length of time. If passed this would allow a department that is forming a retirement fund to grandfather in a person who has been with the department for years. An example would be a volunteer who had served the department for 15 years when a department started a retirement fund. The member would immediately be a qualified member even though there was no money in the account. The member would not have to serve another 10 years to qualify for what would be invested in his name. The percentage of his investment would be determined by the rules that the local department set up and approved by the IRS. He would also have to meet any other requirements of the plan. The rebate for an insurance premium has been in place for a decade and no new money is requested and this has no effect on the ND Employee Fund.

Thank you for your time, and I am asking for your favorable recommendation on this bill. If you have any questions, I would be happy to answer them.

#### NORTH DAKOTA FIREMEN'S ASSOCIATION TESTIMONY

Mr. Chairman and Members of the Committee, my name is Lois Hartman. I am the Executive Director of the North Dakota Firemen's Association. I appear before you today in support of HB1201.

The Governor has held a series of Seminars and Conferences to inspire and encourage community leadership in North Dakota. In those conferences, the challenge of finding volunteers to fill the needs of leadership in the communities was discussed at length. HB 1201 is a tool for recruitment and retention within the fire service.

There are 389 Fire Departments and Fire Protection Districts in North Dakota. Of those, only 4 are full time fire departments, 8 are combination departments and the rest are volunteer departments and fire protection districts. There are about 8,800 firefighters in North Dakota; 245 are from the 4 full time departments and about 20 are from the 8 combination departments. That means that there are about 8,535 volunteer firefighters in North Dakota. The North Dakota Century code requires a fire department or fire protection district to have 15 firefighters in order to be certified. Some of our communities have a hard time getting 15 people to fill their roster.

With an aging population, it is vital to recruit younger firefighters to fill the needs in the communities. Now, I will tell you, that not all communities are having as much of a problem as others, but for the most part, the Fire Service needs a tool to help with the recruitment and retention challenges they are facing.

HB 1201 will allow the volunteer fire departments and fire protection districts the opportunity to establish a firefighter's relief association, if the funds are available from within their own budgets. The fire departments and fire protection districts are funded in part through a special fund in the Insurance Department. The insurance premium tax collected on fire, allied lines, home owners multiple-peril, farm owners multiple-peril, commercial multiple-peril and crop hail insurance is deposited into a special distribution fund, up to a balance of \$2.6 Million annually. The rest of the insurance premium tax dollars are deposited in to the general fund. Chapters 26 and 18 of the Century Code designate these dollars for the fire departments and fire protection districts in which they

This bill is long over due and will be greatly appreciated and accepted by the many statewide volunteer fire departments. It should not matter if you're a volunteer or career firefighter wishing to establish a firefighters relief association. Firefighters should not be treated differently. All firefighters have the same goals and these are to save lives and property.

With the declining membership of many volunteer fire departments across the state, this bill could be utilized as a retention and recruitment tool. The North Dakota century code requires a fire department to have at least 15 members to be a certified department. It would be a means to reward the many volunteers who have given and sacrificed so much for their communities.

If a volunteer firefighter were to die or be injured seriously enough so the firefighter would be unfit to continue as a firefighter, this bill would provide for the spouse and children. Injuries and deaths don't know the difference between a volunteer and career firefighter.


This bill not only helps the volunteer firefighters of the state; it will also benefit the communities by attracting more

had served 20 years, after they passed a retention plan, they doubled that in just 6 years and saw an increase in average years of service. The decision to start a retention plan and the amount to invest it was totally up to the local authorities and subject to their needs and priorities. In other words if equipment or expenses became a problem, they could reduce contributions to the plan at their discretion.

The reason I am telling you this is that some of the money that the local fire departments operate with, come from premium rebates that insurance companies send to the State. This has been an ongoing rebate and this bill doesn't change any of that. The 1997 ruling stated that only departments with full time paid firefighters could use this money to fund retirement accounts. The first thing this bill does si to allow departments to use all or part of this rebate to fund these accounts, and volunteers are eligible to be vested members after they meet the qualifications established by the departments and the State.

The second change is more of a clarification. The state requires a fund member to be invested for 10 years, but it's hard to tell if that means 10 years as a volunteer or 10 years in the Retirement Plan. The bill would allow credit for time in the department to count toward the volunteer's length of time. If passed this would allow a department that is forming a retirement fund to grandfather in a person who has been with the department for years. An example would be a volunteer who had served the department for 15 years when a department started a retirement fund. The member would immediately be a qualified member even though there was no money in the account. The member would not have to serve another 10 years to qualify for what would be invested in his name. The percentage of his investment would be determined by the rules that the local department set up and approved by the IRS. He would also have to meet any other requirements of the plan. The rebate for an insurance premium has been in place for a decade and no new money is requested and this has no effect on the ND Employee Fund.

Testimony for the Government And Veterans Affairs Committee On House Bill 1201 By Dan Hoium, State Fire Marshal February 12, 1999

Chairman and members of the committee, my name is Dan Hoium, and I am the State Fire Marshal. I am appearing today in favor of House Bill 1201.

This bill is long over due and will be greatly appreciated and accepted by the many statewide volunteer fire departments. It should not matter if you're a volunteer or career firefighter wishing to establish a firefighters relief association. Firefighters should not be treated differently. All firefighters have the same goals and these are to save lives and property.

With the declining membership of many volunteer fire departments across the state, this bill could be utilized as a retention and recruitment tool. The North Dakota century code requires a fire department to have at least 15 members to be a certified department. It would be a means to reward the many volunteers who have given and sacrificed so much for their communities.

If a volunteer firefighter were to die or be injured seriously enough so the firefighter would be unfit to continue as a firefighter, this bill would provide for the spouse and children. Injuries and deaths don't know the difference between a volunteer and career firefighter.

This bill not only helps the volunteer firefighters of the state; it will also benefit the communities by attracting more

firefighters, which will ensure a fire safe community in which to live and play.

The volunteer fire departments respond to the same kinds of fires that career firefighters do, often undermanned, and under equipped. This often puts them at a greater risk for injury and loss of life.

Chairman and members of the committee, I urge you to support this bill. Your support of this bill will have a great influence on attracting new members to volunteer fire departments and retaining current members.
