HCR3068 is to study the feasibility and desirability of an equitable sharing, between the state and counties, of the costs of providing facilities for the delivery of state-funded judicial and clerk of court services.

SENATOR STENEHJEM opened the hearing on HCR3068 at 10:00 A.M.

SENATOR STENEHJEM testified in support of HCR3068. This is the third of the measures recommended on the consensus council process and the Judicial Committee of the issues that exist as an area of concern of the Judiciary and for the counties of the State of North Dakota on the provision of court room and office facilities for operation of the Courts of North Dakota. The House added that the consultation would take place in the study with the Association of Counties
