Testimony on SB 2007 Prepared for the **House Appropriations Committee**

March 2, 1999

Chairman Byerly and members of the Committee, good afternoon. For the record, my name is Mark Bachmeier and I am the Interim Commissioner at the Department of Labor.

1998 was a year of considerable change at the Department of Labor. In August, Commissioner Hagen resigned after nearly eight years of elected public service. He was preceded in his departure by his Deputy Commissioner of seven years, Ron Ness, who left the Department of Labor in June. Their legacy is, I believe, an agency that is efficient, objective and fair in dealing with North Dakota employers and employees, and proactive in reducing violations of labor and equal employment opportunity law.

Including the Commissioner, the Department of Labor has seven authorized FTE, one of which is currently funded at 75%, and administers five program areas in addition to the general administration of the agency. All staff are trained in all program areas sufficiently to provide general assistance to the public. We received nearly 22,000 such inquiries and requests for services during 1998. In the vast majority of these instances, the staff person who answered the call or greeted the person entering the department was able to provide the necessary assistance.

When Commissioner Hagen took office, he implemented an effort to educate the public on labor law on the assumption that if employers know their obligations and responsibilities under the law, they will tend to comply with the law. This effort included the creation and distribution of informational brochures; the development and distribution of a wage and hour poster that contains plainly written explanations of labor law provisions; and an effort to inform the public directly through presentations and seminars. During 1998, we mailed over 900 informational packets to citizens, not counting those we distributed at presentations, conferences, and through our web site. We conducted 54 presentations on labor and equal employment law to employer groups throughout the state. The total attendance at these presentations was 1,903 or an average of 35 per presentation.

This public education effort has paid clear dividends. In 1998, the department received a record low 234 claims for unpaid wages. The year Commissioner Hagen took office, 1990, there were 698 such claims. Our Wage and Hour Division closed a total of 244

claims during 1998 and collected more than \$54,000 in unpaid wages for employees through formal claims, informal audits, and compliance reviews.

Our other major division, Equal Employment Opportunity, opened 107 charges of employment discrimination during 1998. The division completed investigations and closed 85 charges and negotiated settlements totaling \$39,515.

Other 1998 activities of the department include:

- Filing 1,680 Employment & Age Certificates (work permits) for 14 and 15 year olds who became employed.
- Licensing and conducting on-site reviews of 18 employment agencies in the state.
- Verifying the independent contractor status of 26 contractors.
- Conducting 7 employer compliance reviews.
- Conducting 51 on-site investigations.
- Reviewing 19 employer policy manuals.

As well as I believe the Department of Labor operates currently, I think we need to prioritize work to improve three areas during the 1999-2001 biennium. First, we are technologically behind where we should be. We need to replace several antiquated personal computers, purchase a server for our network, and upgrade some of our software packages. We need to improve the record keeping systems for our programs and activities and generate statistical data more regularly. We have electronic database programs for record keeping and automating some processes related to wage claims and charges of employment discrimination but they need improvement and virtually all other records for the agency are maintained in either hard copy or crude electronic files. In addition, our web site, which I believe has great potential for aiding our efforts to provide information to the public, needs updating and improvement.

Secondly, we need to assess our reported law violations and public education efforts geographically. We conduct presentations anywhere in the state upon request. However, the distribution of presentations does not necessarily correspond to the distribution of reported violations. We may need to actively seek more opportunities to speak in specific locations in the state.

Finally, the independent contractor verification process needs review. The present system is underutilized, the criteria for verification are somewhat ambiguous, and the process involves little collaboration among the affected agencies.

The Executive Budget Recommendation for the Department of Labor contained a proposed general fund increase of \$10,509 or 1.7% over our current appropriation, excluding the compensation package. This increase remains intact in the current engrossed version since the only cuts made by the Senate were to the compensation package. A detailed breakdown of our current and recommended appropriations is attached to this testimony. You will note that the overall increase is a net effect of proposed increases and cuts in many areas. The increase in salaries is to fully fund our clerical position. Currently, our secretary works only four days per week, leaving us to cover the duties of that position with other staff twenty percent of the time. The proposed net increase of \$9,019 in operating expenses is related in large part to the implementation of our technology plan and costs associated with an anticipated update to our current wage and hour poster. The proposed increase of \$3,250 in equipment is to implement our technology plan.
