SCR4032 is to study the family law process in North Dakota with a focus on a review of existing statutes, the coordination of procedures, and the further implementation of alternative dispute resolution methods.

SENATOR STENEHJEM opened the hearing on SCR4032 at 9:45 a.m.

All were present.

SANDI TABOR, State Bar Association, testified in support of SCR4032. During a conference, people talked about the status of family law in the state. The Chief Justice suggested that we contact the Bar Association and the Joint Family Law Task Force and do a joint study with the Task Force and the Legislature and do some further work in the family law area. We hope the Task Force would be able to provide the expertise that they have developed to talk about different things that are happening in family law and what we could do about it. One of our

biggest concerns is that the statutes are not very well coordinated. Also further movement in the area of mediation in family law. We would like to develop mandatory mediation orientation.

SENATOR STENEHJEM stated that we have anticipated having a joint meeting with the Legislative Interim Committee and the Family Task Force.
