Minutes:

The committee was called to order, and opened the hearing on SCR 4002. Chairman Byerly read the beginning of the resolution.

Don Wolf: Here from the Legislative Counsel to explain the resolution, not here for or against the bill. The resolution authorizes the budget section to hold public legislative hearings required to receive the federal block grant funds during the period from the recess through September 30, 2003. Currently only the Community Services Block Grant requires a public hearing, and that was held during OMB's appropriation hearing.

Chairman Byerly: So this doesn't change that requirement.

Response: No, but just in case a grant may come along and require a hearing, this gives the authorization for that.

Rep. Skarphol: This is just a formality to meet federal rules?

Response: Yes. Just standard procedure that's been done for a number of years.
