Minutes: **Rep.Devlin, Chairman** opened the hearing on HB 1337, A Bill for an Act to amend and reenact subsection 2 of section 28-32-10 of the North Dakota Century Code, relating to notice of administrative agency rulemaking to members of the legislative assembly who were sponsors of legislation to be implemented by rules; and to provide an effective date.

Rep. Boehning representing district 27 and a prime sponsor of HB 1337 explained that his reason for bringing forth the bill was that it is his intent to keep the legislators in the loop. When a legislator has gotten a piece of legislation passed and the agency is about to or has implemented the rules pursuant to that legislation -- the legislator at least is advised of the fact. It is surprising sometimes to find that the rules come out so different than what the intent was when the legislation was drafted. At least the legislator would have some in put into the outcome.

Rep. Ekstrom (32.7) I agree with this and believe most legislators would do this for free. But, was there any discussion about a per diem for a legislator to follow up on this?

Rep. Boehning: The idea was that we would be furnish a copy of the proposed legislation (?rules). There has been some discussion of that in the past. This designed to keep us informed.

Rep.Devlin, Chairman (33.8) this bill doesn't require you to come out here to do anything but just requires the agencies to send you a copy of whatever they are coming up with or promulgated as the result of your bill.

Rep. Boehning: Correct. To have things E-mailed to us or sent to that we can go on the webb site to get the information -- isn't what I have in mind because we don't always get to check our E-mail but if we can get a hard copy to read is what I am looking for.

Rep. Wrangham (34.8) Would this involve a lot of extra work for the agencies or the legislative council or whoever would have to do this?

Rep. Boehning: I don't see it as anything extra -- we would automatically be put on the mailing list for their distributions. It would be a maximum of six sponsors an any bill.

Rep.Devlin, Chairman: (35.5) One of the first concerns I had was the language which said " or otherwise affected by the proposed rule". That could be everybody in the legislature or the public --- if the intent is only the sponsors that is not so broad.

Rep. Kretschmar (36.1) Assuming an agency was changing the rules on some legislation that was passed five years ago --

Rep. Boehning: Maybe an amendment would be in order to limit to the last -- past legislative session.

There was no testimony for nor against HB 1337; however,

Bruce Hicks, representing the State Industrial Commission Oil and Gas Division asked to testify

from a neutral position on the bill. We had some concerns which several of the committee have already hit upon. First we note that this places the burden on the agency and we believe it should perhaps be on the Legislative council. They know the procedure. Again a question of the "otherwise effected" language. It does appear twice. We think it could be stricken without destroying the intent of the bill.

Rep. Koppelman (39.5) When you look at the process of making administrative rule I don't think this would be onerous at all.

Bruce Hicks: I do agree that it is a good idea that the sponsors should notified.

Rep. Wrangham (43.8) In regard to who would send this out -- it does specify that agency shall send it out. Since this is something the agency would send out so it would be only adding a couple of more names to the mailing list.

There being no further testimony, **Rep.Devlin**, **Chairman** closed the hearing on HB 1337. (45.4)

Minutes:

Chairman Cook called the Senate Political Subdivisions to order. Roll call was taken with five members present and one absent.

Chairman Cook opened the hearing on HB 1337 relating to notice of administrative agency rulemaking to members of the legislative assembly who were sponsors of legislation to be implemented by the rules.

Representative Randy Boehning, District 27, SW Fargo ND introduced HB 1337. It is a bill which will help legislators, constituents and the like. It will allow legislators the opportunity with out having too check with agencies to see if they are working on rules which pertain to their newly approved legislation. What this bill will do is help keep us informed of the progress and the intent of our legislation. It will supply the legislators with up to date information with out having to ask for it

Senator Hacker: Is there going to be an opportunity to deliver a copy by E-Mail?

Rep. Boehning: We are recognizing E-Mail as an official form of communication. I wouldn't have any problem with E-Mail.

Chairman Cook: Do we have a problem out there that we are trying to take care of?

Rep. Boehning: I think sometimes bills and laws that we are ready to pass are probably some times not getting some of the intent and this allows us to take a look at them before they go to administrative review and every thing gets approved. This way we can get a copy of them and check our intent.

Senator Triplett: My concern is that sometimes you have up to six sponsors on a given bill and maybe only one really cares about it and the others are doing it as a favor. Won't this end up being a lot of paper and effort to make sure everyone gets a notice.

Rep. Boehning: I guess right now anyone of us can ask for copies of legislative rules. This would basic allow the bill sponsors to make sure they do get a copy of the bill so we can take a look at them.

Senator Hacker: Would you want to put a sunset clause on here to look at it in two years?

Rep. Boehning: That was not the intent of it but if the committee so chooses than we can see how it works.

Bruce Hickes, Assistant Director of the North Dakota Industrial Commission Oil and Gas Division. The commission is not opposing. As an administrative agency we are very concerned. The part we have a problem with is where it says "or otherwise affected by". We believe that could be interpreted to mean that if you have an existing rule out there and you are amending it, maybe the rule was implemented around twenty years ago, that you would have to go back and find some sponsors. We have been told before that this was only going to be for those rules that

have been implemented but we think this opens the door for a lot of controversy and this could be very ownerous of us if we were having to notify all these other parties. That is our main concern. The sunset clause maybe would be a good idea as far as we are concerned.

Senator Dever: Would your concerns be relieved if we amended it to say in the most recent legislative session.

Bruce Hixes: I believe if you struck "or if otherwise affected by", that is in there twice, that would do it or by also saying some language as you suggest would also work.

Tom Tuppa, appeared neutral, representing several regulatory boards that they work with, social workers being one of the biggest ones. We have some of the same concerns that were eluded to by the previous speaker. Cosponsor and sponsor, we don't know how far back that goes. One of the boards that we work for is twenty five years old, do we have to go back to that original sponsor that introduced the legislation twenty five years ago? Of course we have the same concern as was earlier identified "or other wise affected".

Senator Gary Lee: Does the date on the bottom, after July 31, 2005, effect that at all in terms of your concern.

Tom Tuppa: Perhaps it would this time around but if it stays in there, ten years from now would you have to apply it retroactively back to 2005. Legal council would probably have to make some determinations on that.

No further testimony.
