TESTIMONY SUPPORTING HB 1355 HOUSE GOVERNMENT AND VETERANS AFFAIRS COMMITTEE

Good morning Chairman Haas and members of the House Government and Veterans Affairs committee. I am Representative Ralph Metcalf from the greater District 24 representing North Dakotans living in 22 townships in Western Barnes County and 10 townships of Northwestern Ransom County.

This bill has two purposes. First, to allow the Administrator of the North Dakota Veterans Home in Lisbon, ND to be addressed as Commandant if the individual hired to this position under the provisions of section 37-18.1-03 is an honorably discharged veteran. Secondly, the title name "Administrator" replaces the name "Commandant" throughout the bill to recognize that the title of the person in charge of the Veterans Home is "administrator" and as administrator has certain inherent responsibilities. These changes should have been made during the 2003 legislative session but were overlooked when the title of the person in charge of the Veterans Home was changed. There are several other word corrections made to clarify the code.

For the benefit of those military members staying at the home, the term commandant is more acceptable and allows them to show the respect for the position of authority as normally shown in a military command. It is the intent that the administrative committee on veterans' affairs will establish how and when the title of commandant will be used. The title of commandant is a long established title connected directly to the home. Tradition and military pride emphasizes the necessity to insure that this title is continued whenever appropriate, when the administrator is a veteran.

There is no intent with this change to try to undermine the important requirements to select the best person possible whenever a different administrator must be chosen. The only advantage a veteran would have when a selection is made is through the veteran preference procedure. If an individual who is not a veteran is the best qualified applicant, selection would probably go to that person.

Mr Chairman, that concludes my testimony and I will be happy to answer any questions.

My name is John L. Jacobsen. I am the chairman of the Legislative Committee of the North Dakota Veterans Coordinating Council. I am a member of both the VFW and the American Legion. I am also a member of the VFW National Legislative Committee. We work directly with our Members of Congress on legislation at the national level.

I served 29 years in the ND National Guard and the US Army Reserve, retiring in 1995 with the rank of Colonel. I served on active duty in 1991 in the Persian Gulf stationed in the United Arab Emirates.

The NDVCC membership is comprised of 15 members representing the five (5) veterans' organizations in the state. (3 from each organization) They are:

- > American Legion
- > AMVETS
- > Disabled American Veterans (DAV)
- > Veterans of Foreign Wars (VFW)
- > Vietnam Veterans of America (VVA)

These organizations represent approximately 60,000 veterans currently living in North Dakota.

I am a member of the Legislative Committee of the NDVCC. I am not a member of the NDVCC but report directly to them. In order for the Legislative Committee to support any bill brought up before our Legislature, concurrence must be unanimous, that is all 15 members must agree that we should support the bill. A single negative response will kill our support.
